## RACE 1: NARACOORTE RADIATORS / SABOIS MAIDEN PLATE - 1000 metres

**JOHN'S STRATEGY** (J. Lorensini) - in the vicinity of the 700 metres was obliged to be steadied and altered course to the inside of REGINA MARGHERITA, which rolled out.

**LONGMIRE** (C. Caserta) - laid out in the straight. In the vicinity of the 100 metres rolled out and bumped REGINA MARGHERITA.

**ROCKFACE LOUIE** (C. Puls) - raced wide without cover throughout the event. Raced greenly in the early and middle stages of the event. In the vicinity of the 900 metres jumped a part of the track for no apparent reason. A post-race veterinary examination revealed no visible abnormalities.

**REGINA MARGHERITA** (D. Tourneur) - in the vicinity of the 700 metres shifted out and away from LONGMIRE. In the vicinity of the 100 metres was bumped by LONGMIRE, which rolled out.

# RACE 2: BUSHMANS ARMS HOTEL / SABOIS MAIDEN PLATE - 1430 metres

The start of this event was delayed approximately eight minutes.

**TENOSSUH** (D. Tourneur) - fractious in the barriers. Galloped riderless for some distance before being captured. A late scratching by order of Stewards at 2.33 pm. Trainer advised the gelding would be required to perform to the Stewards satisfaction in an Official Barrier Trial or Approval Jump-Out prior to accepting for a future race.



## RACE 2: BUSHMANS ARMS HOTEL / SABOIS MAIDEN PLATE - 1430 metres (Cont'd)

CARIBBEAN SILK (G. Lo) - a post-race veterinary examination revealed no visible abnormalities.

MARAVILLOSO (K. Bishop) - refused to load. A late scratching by order of Stewards at 2.38 pm. Trainer advised the mare would be required to perform to the Stewards satisfaction in two Official Barrier Trial prior to accepting for a future race.

**WARATAH GIRL** (J. Maund) - fractious in the barriers. A late scratching by order of Stewards at 2.33 pm. Trainer advised a warning had been placed on the mare in relation to its barrier manners.

#### RACE 3: MUNRO & GRIGG AUTO REPAIRERS BENCHMARK 64 HANDICAP - 2000 metres

DUQUESSA (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

**HAKERAK** (S. Logan) - inside the 500 metres shifted in when insufficiently clear of GO WALLY. Rider pleaded guilty to a charge of careless riding under AR137(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 25 January and to conclude at midnight on Saturday, 12 January 2019: a period of three meetings.

**GO WALLY** (E. Boyd) - inside the 500 metres checked to avoid the heels of HAKERAK, which shifted in and lost its position.

#### RACE 4: HANSEN DESIGN & PRINT BENCHMARK 60 HANDICAP - 1000 metres

The start of this event was delayed approximately four minutes.

**JUST LIKE HEAVEN** (E. boyd) - refused to load. A late scratching by order of stewards at 3.44 pm. Trainer was advised the mare must perform satisfactorily in an Official Barrier Trial and an Approval Jump Out prior to being presented for a future race.

STREAK OF LIGHT (G. Lo) - slow to begin.

#### RACE 5: NARACOORTE RECYCABLES BENCHMARK 56 HANDICAP - 1200 metres

**BROBAK** (P. Marks) - in the early stages of the race got its head up for some distance while being restrained. Difficulty obtaining clear ground between the 300 metres and the entrance to the straight.

**BRIGHT BELLE** (J. Potter) - held up from the vicinity of the 400 metres until the 50 metres had to alter course to the outside of the field to obtain clear ground.

#### RACE 6: HENSCHKE INDUSTRIES BENCHMARK 60 HANDICAP - 1430 metres

The start of this event was delayed approximately three minutes.

CRYSTAL GLASS (S. Logan) - required the saddle to be tightened at the barriers. From the 1200 metres got its head up while being restrained for some distance. Rider explained the mare began well and settled where expected. Rider added that from the 1200 metres the mare began to overrace so elected to restrain CRYSTAL GLASS in an attempt to gain clear ground to the outside of the field and in doing so CRYSTAL GLASS got its head up for some distance until the 600 metres where she was able to obtain clear. She further stated that the mare finished the race off well.

**DYAGILEV** (J. Maund) - required the bridle to be adjusted at the barriers.

**DANGEROUS REBEL** (J. Potter) - laid out throughout the event. A post-race veterinary examination revealed no visible abnormalities.



## RACE 6: HENSCHKE INDUSTRIES BENCHMARK 60 HANDICAP - 1430 metres (Cont'd)

**LADY DEE DEE** (E. Boyd) - required gear adjustments at the barriers. Rider accidentally dropped her whip in the vicinity of the 50 metres.

**REEF'S REVENGE** - a late scratching by order of Stewards at 2.18 pm as there were no riders available.

**SPECTRUMS BITE** - a late scratching by order of Stewards at 10.21 am as there were no riders available.
