Report on Race Meeting held at Port Lincoln Racecourse  
by the Port Lincoln Racing Club on Monday, 31 December 2018

**TRACK:** Good 4 (Track with some give in it)

**RAIL:** Out 2 metres 800 metres to Winning Post, out 1 metre remainder.

**RACE 1: AVIS PORT LINCOLN BENCHMARK 64 HANDICAP - 1960 metres**

**HARD AT IT** (T. Pannell) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**ONWARD** (B. Sweeney) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100. In assessing penalty Stewards took into account the distance and context of the race and that the rider was endeavouring to encourage his mount.

**TASSIE** (J. Maund) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 2: LOCAL LIQUID / SABOIS PLUS MAIDEN/CLASS ONE PLATE - 1750 metres**

**GOLD MAESTRO** (J. Maund) - in the vicinity of the 800 metres improved around the field to a position in the lead. In the vicinity of the 100 metres rolled in onto BURGUNDEE MISS, which was inconvenienced.

**HAND TO HAND (NZ)** (A. Chan) - jumped away awkwardly and was slow into stride.

**BALWARRA SPIRIT** (J. Toeroek) - raced keenly in the early stages of the event. In the vicinity of the 1200 metres began to race fiercely and was obliged to be restrained as CLAREFELILLI rolled in. In the vicinity of the 400 metres was inconvenienced as CLAREFELILLI rolled out and contacted the gelding.

**BURGUNDEE MISS** (R. Hurdle) - in the vicinity of the 100 metres was inconvenienced for a stride as GOLD MAESTRO rolled in.

**RACE 2: LOCAL LIQUID / SABOIS PLUS MAIDEN/CLASS ONE PLATE - 1750 metres (cont'd)**

**CLAREFELILLI** (G. Lo) - in the vicinity of the 1200 metres rolled in onto BALWARRA SPIRIT, which was racing fiercely and was obliged to be restrained. Rider was severely reprimanded and advised to take greater care in future. In the vicinity of the 400 metres rolled out onto BALWARRA SPIRIT, contacting that gelding and was inconvenienced. A post-race veterinary examination revealed a higher than expected recovery heart rate.

**RACE 3: VETS ON EYRE / SABOIS MAIDEN PLATE - 1390 metres**

**HORIZON WATCH** (G. Lo) - - jumped away awkwardly. Raced keenly during the event. Hung in throughout the event. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr T. Jolly, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**ARTFUL TEEPA** (K. Lau) - became fractious en route to the course. Was examined by the Club's Veterinary Surgeon on arrival on course and was passed fit to start.

**THE LEPRECHAUN** (D. Caboche) - taken out on jumping away by AMERICAIN SAPPHIRE, which shifted out.

**AMERICAIN SAPPHIRE** (A. Chan) - jumped away awkwardly and shifted out onto THE LEPRECHAUN. Hung out throughout the event.

**SHARVANOS** (L. Goomany) -lost its position on jumping away when tightened onto AL AQUILAH as THE LEPRECHAUN was taken out.

**RACE 4: PORT LINCOLN REAL ESTATE / SABOIS MAIDEN PLATE - 1000 metres**

**TAJAVEDO** (D. Caboche) - slow to begin. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**HOLLYWOOD MISS** (L. Goomany) - hung out rounding the home turn.

**ALWAYS BE TRUE** (K. Lau) - jumped away awkwardly.

**CRY OUT LOUD** (G. Lo) - reared and fell backwards in the parade ring. Was examined by the Club's Veterinary Surgeon on arrival at the barriers and passed fit to start. Slow to begin.

**PUT DEBEERS ON BAR** (S. Fawke) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 5: FOURIER TECHNOLOGIES BENCHMARK 80 HANDICAP - 1390 metres**

**BURNRO** (J. Maund) - held up for clear running from in the vicinity of the 400 metres to approaching the 200 metres when it shifted in to obtain clear running. From in the vicinity of the 50 metres until the finish raced in restricted room between DEBEERSONUS and IT'S HUMPHREY.

**RACE 6: LINCOLN SAND SUPPLIES - NT & DA DICKSON BENCHMARK 54 HANDICAP - 1390 metres**

**MACKIE** (J. Toeroek) - jumped away awkwardly. Hung in throughout the event and under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**SAINT VALENTINE** (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 6: LINCOLN SAND SUPPLIES - NT & DA DICKSON BENCHMARK 54 HANDICAP - 1390 metres (cont'd)**

**COOL RUNNINGS (NZ)** (R. Hurdle) - raced wide without cover throughout the event.

**CHOUX BACQUAT (NZ)** (A. Chan) - slow to begin.

**NOUVELLOKOVA** (D. Caboche) - over-raced in the early and middle stages of the event.

**OBLIQUE LINE** (S. Logan) - bumped with TILBURY on jumping away.

**TILBURY** (K. Bishop) - bumped with OBLIQUE LINE on jumping away.

**RACE 7: LINCOLN ESTATE WINES BENCHMARK 56 HANDICAP - 1390 metres**

**BAM** (R. Hurdle) - approaching the 1200 metres shifted in when insufficiently clear of CHASE SOPRANO, which was tightened when taken in onto LOCKS WELL, which was tightened and taken in onto ISLE OF LIGHT, which was obliged to be steadied and lost its position. Rider was found guilty of a charge of careless riding under AR137(a) and was suspended from riding in races for a period to commence midnight Wednesday, 16 January 2019 and to conclude midnight Wednesday, 23 January 2018, a period of 4 meetings.

**ISLE OF LIGHT** (J. Maund) - approaching the 1200 metres was obliged to be steadied and lost its position when tightened by LOCKS WELL, which was taken in when tightened by CHASE SOPRANO, which was taken in and tightened by BAM. A post-race veterinary examination revealed no visible abnormalities.

**LOCKS WELL** (T. Pannell) - approaching the 1200 metres was tightened when taken in by CHASE SOPRANO, which was tightened and taken in by BAM. A post-race veterinary examination revealed no visible abnormalities.

**ROYAL PARADE** (K. Bishop) - Trainer, Mr G. Searle, was reprimanded under AR59A for failing to provide the Thoroughbred Identification Card. In determining penalty Stewards took into account Mr Searle's good record under this Rule. The horse was permitted to start as it was able to be identified from records held by the Stewards. Proved difficult on exiting the mounting yard. Underwent a pre-race veterinary examination on arrival at the barriers and was passed fit to start. Trainer, Mr G. Searle, was advised that a warning had been placed on the mare in relation to its pre-race behaviour.

**CHASE SOPRANO** (S. Logan) - approaching the 1200 was tightened and taken in by BAM, which shifted in when insufficiently clear.

**ANOTHER MARTINI** (D. Caboche) - laid in under pressure in the straight.

**RACE 8: RSM BENCHMARK 64 HANDICAP - 1000 metres**

**TINTAGEL ROCKER** (S. Logan) - raced keenly in the early and middle stages of the event. Held up for clear running from the 400 metres until in the vicinity of the 200 metres when it was obliged to shift in to obtain clear running.

**MR JAZZ MAN** (G. Lo) - a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr T. Trenowden, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**MR LIBERTY** (T. Pannell) - trainer, Mr D. Carrison, made a submission to Stewards to remove the earmuffs from the gelding. Stewards granted permission for this to occur. Mr Carrison was fined \$200 under AR140B.

**RACE 8: RSM BENCHMARK 64 HANDICAP - 1000 metres (cont'd)**

**STREETSHAVENONAME** (J. Maund) – in the vicinity of the 150 metres raced in restricted room for a short distance between MR JAZZ MAN and BARE WITNESS, which was taken out Thereafter had difficulty obtaining clear ground over the final 100 metres of the event.

**NITRO MAGIC** (L. Goomany) – knuckled on jumping away. In the vicinity of the 150 metres shifted out onto BARE WITNESS, which was inconvenience when taken wider. Rider was severely reprimanded and advised to take greater care in future. A post-race veterinary examination revealed a higher than expected recovery heart rate.

**BARE WITNESS** (A. Chan) – in the vicinity of the 150 metres was inconvenienced and taken wider onto STREETSHAVENONAME by NITRO MAGIC, which shifted out.

**RACE 9: KEMP REAL ESTATE BENCHMARK 56 HANDICAP - 1210 metres**

**INNER STRENGTH** (K. Lau) – in the vicinity of the 1000 metres was inconvenienced as CALL ME HERBIE shifted out abruptly and as a result was taken out and contacted KENTUCKY FIREBALL.

**KENTUCKY FIREBALL** (G. Lo) – in the vicinity of the 1000 metres was contacted and taken wider onto RAYLEIGH as INNER STRENGTH, which was inconvenienced, was taken out.

**CALL ME HERBIE** (J. Toeroek) – in the vicinity of the 1000 metres, when racing greenly, contacted the running rail and shifted out abruptly onto INNER STRENGTH, which was inconvenienced. A post-race veterinary examination revealed no visible abnormalities.

**RUBY'S REWARD** (A. Chan) – hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**RAYLEIGH** (S. Logan) – in the vicinity of the 1000 metres was inconvenienced as KENTUCKY FIREBALL was taken out. As a result RAYLEIGH contacted STAR MOVER.

**STAR MOVER** (L. Goomany) – in the vicinity of the 1000 metres was taken wider by RAYLEIGH, which was inconvenience when taken out.
