#### RACE 1: FESTIVAL HIRE / SABOIS MAIDEN PLATE - 900 metres

**AQUILINE** (R. Hurdle) - shifted in on jumping away contacting RIZSKI. A post-race veterinary examination revealed no visible abnormalities.

CANIDAE (S. Fawke) - shifted in slightly in the vicinity of the 600 metres onto HOUNSLOW RUNNER.

RIZSKI (K. Lau) - contacted on jumping away.

**HOUNSLOW RUNNER** (D. Caboche) - had to be steadied momentarily in the vicinity of the 600 metres when CANIDAE shifted in slightly. Laid in under pressure in the straight. A post-race veterinary examination revealed abnormal upper respiratory noise. Trainer advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

#### RACE 2: MURRAY BRIDGE VILLAGE BUTCHERS BENCHMARK 56 HANDICAP - 1200 metres

The start of this event was delayed approximately five minutes.

**BABITZIN** (G. Lo) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**BUCK'S ROW** (A. Chan) - reared over after being loaded and became cast resulting in all other runners having to be removed from the barriers. A late scratching on veterinary advice at 2.07 pm. Trainer Ms K. Byrnes advised the gelding would be required to be tractable in the barriers in an Official Barrier Trial prior to accepting for a future race. Rider examined by the First Care Medical Personnel and passed fit to fulfil his remaining engagements. BUCK'S ROW was reexamined after the event, revealed to be lame in the near hind leg. First aid administered. Trainer Ms K. Byrnes was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

SHARK MIRAGE (E. Boyd) - raced fiercely in the early and middle stages of the event.

BIRDS IN HAND (R. Clark) - laid out under pressure in the straight.

# RACE 2: MURRAY BRIDGE VILLAGE BUTCHERS BENCHMARK 56 HANDICAP - 1200 metres (Cont'd)

**RED DAZZLE** (S. Fawke) - raced wide without cover throughout the event. Laid out over the concluding 900 metres of the event.

### RACE 3: SAMBEC SHEDS / SABOIS MAIDEN PLATE - 1400 metres

**ALMADRAM** (T. Pannell) - held up from the vicinity of the 400 metres until near the 300 metres and then was obliged to be steadied when awkwardly placed on the heels of HEROES QUEST, which rolled out slightly and inside BUJOLASS and was only able to obtain clear ground approaching the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

**BRYBECK** (R. Clark) - became held up inside the 300 metres when HEROES QUEST rolled in slightly and was only able to obtain clear ground approaching the 100 metres when able to ease and alter course to the outside of runners.

**HEROES QUEST** (J. Maund) - inclined to shift about under pressure in the straight. In the vicinity of the 300 metres rolled out slightly onto ALMADRAM and then inside the 300 metres rolled back in onto BRYBECK. Rider advised to make a greater effort to keep his mounts straight when they commence to shift ground.

PLYMPTON (J. Potter) - slow to begin.

**ROCKWOOD BOY** (A. Chan) - raced fiercely in the early and middle stages of the event. Rider reported the gelding raced greenly throughout the event. A post-race veterinary examination revealed no visible abnormalities.

TIME RULER (W. Cave) - hampered on jumping away.

**CALCUTTA** (J. Holder) - shifted in shortly after the start onto TIME RULER. In the vicinity of the 250 metres Improved onto the heels of WARMINGTON RUN, which commenced to give ground and had to be steadied for a short distance.

**WARMINGTON RUN** (D. Torneur) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

JEWELLER'S CLUB (K. Bishop) - jumped away awkwardly.

#### RACE 4: MARCHSPREADERSALES.COM NEW YEAR'S CUP - 1400 metres

KARLOVASI (K. Lau) - raced keenly in the early and middle stages of the event.

**LITTLE WHITE CLOUD (IRE)** (S. Logan) - underwent a pre-race veterinary examination and passed fit to race. Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

THIS KID ROCKS (J. Holder) - dipped on jumping away.

**LIEDER** (S. Cahill) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

#### RACE 5: MURRAYLANDS FIRE & SAFETY BENCHMARK 64 HANDICAP - 900 metres

VICKI'S BOY (K. Lau) - jumped away awkwardly and was slow into stride.

STYELLA (J. Holder) - shifted out on jumping away and contacted PANDEIA.

JAWS AND MINE (J. Potter) - raced wide without cover throughout the event.

**PANDEIA** (K. Bishop) - inconvenienced on jumping away when contacted by STYELLA. A post-race veterinary examination revealed no visible abnormalities.

#### RACE 6: CARLTON DRAUGHT BENCHMARK 56 HANDICAP - 1600 metres

**SPRINGFIELD LEW** (E. Boyd) - lost its off hind plate during the event. A post-race veterinary examination revealed no visible abnormalities.

**EXALTED BLOOM** (K. Bishop) - raced wide without cover throughout the event.

**EXALTED HONEY** (J. Holder) - slow to begin.

**DISCO REBEL** (R. Clark) - unable to improve from the vicinity of the 600 metres until the 400 metres when awkwardly placed on the heels of RUSH OF BLOOD, which had commenced to give ground.

MISTY HALO (J. Maund) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**SVETLANA'S ARROW** (K. Lau) - laid out under pressure in the straight. A post-race veterinary examination revealed the mare to be lame in both forelegs. Trainer Mr K. Sweeney was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

CRYSTAL ICON (W. Cave) - jumped away awkwardly.

**BLACK HAT (NZ)** (D Tourneur) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

#### RACE 7: GRANDISONS BENCHMARK 60 HANDICAP - 1400 metres

**HOLY JUAN** (R. Clark) - slow to begin. Laid in under pressure in the straight. Near the 200 metres shifted in onto FANDANGO. Rider reminded of her obligations when her mounts begin to shift ground.

CANNOT BE SERIOS (NZ) (S. Cahill) - laid in under pressure in the straight.

**TEXAS MILLER** (J. Maund) - in the vicinity of the 1200 metres shifted in slightly and inconvenienced IN THE FAST LANE. Rider reminded of his obligations when shifting ground.

**JIMMYTOWN JEWEL** (J. Holder) - slow to begin. In the vicinity of the 300 metres had difficulty in obtaining clear ground for a short distance and was obliged to alter course. A post-race veterinary examination revealed no visible abnormalities.

**IN THE FAST LANE** (R. Hurdle) - raced keenly in the early and middle stages of the event. In the vicinity of the 1200 metres was inconvenienced when TEXAS MILLER shifted in.

**FANDANGO** (E. Boyd) - had to be steadied for a short distance in the vicinity of the 200 metres when HOLY JUAN shifted in.

**DAPPER AFTER DARK** (S. Fawke) - a post-race veterinary examination revealed the gelding had bled from both nostrils. Trainer, Mr J. Hickmott, was advised that as this was the gelding's second bi-lateral bleed it was barred from racing for life in accordance with AR53A.
