Report on Race Meeting held at Morphettville Racecourse  
by the South Australian Jockey Club on Sunday, 19 January 2019

**RACE 1: WINNING EDGE PRESENTATIONS TWO-YEAR-OLD PLATE - 1050 metres**

**OUTPOST** (R. Hurdle) - began awkwardly, shifted in and contacted SHEZA LITTLE POSH, which was hampered.

**SOWPODS** (D. Tourneur) - pigrooted en route to the barriers, struck the outside fence near the 500 metres dislodging its rider and galloped some distance before it was caught near the barriers. Underwent a pre-race veterinary examination which revealed a laceration to its near fore shoulder and near hind leg and was ruled unfit to start. First aid administer. Acting on this advice Stewards declared SOWPODS a late scratching at 2.23 pm. SOWPODS was referred to Morphettville Equine Clinic for further treatment.

**SHEZA LITTLE POSH** (C. Caserta) - hampered at the start and unable to maintain its position and thereafter raced greenly. Laid in, in the straight. Approaching the 200 metres laid in onto the heels of OUTPOST and was obliged to shift to the outside of that horse to obtain clear running. A post-race veterinary examination revealed no visible abnormalities.

**SPLENETIC** (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 2: NUTELLA PALOOZA - APRIL 20 AT MORPHETTVILLE RACECOURSE HANDICAP - 1539 metres**

**SIR GARFIELD** (R. Hurdle) - rolled in near the 200 metres and contacted **AURORA CHARM**.

**AURORA CHARM** (H. Coffey) - near the 200 metres rolled in onto **SURREAL IMAGE**, which was inconvenienced, and shortly thereafter was contacted by **SIR GARFIELD**, which rolled in.

**SURREAL IMAGE** (T. Pannell) - shifted out at the start and contacted **CLAREFELILLI**. A post-race veterinary examination revealed no visible abnormalities.

**YANKEE EYES** (K. Crowther) - inside the 1200 metres became awkwardly placed on the heels of **CLAREFELILLI** for several strides (pace related).

**ST GEORGES VAULTS** (S. Fawke) - inclined to lay in, in the straight. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200.

**CLAREFELILLI** (D. Tourneur) - contacted at the start by **SURREAL IMAGE**, which shifted out, and was taken wider.

**RACE 3: MEDALLION HOMES HANDICAP - 1200 metres**

**BUNGALALLY BELLE** (K. Crowther) - underwent a pre-race veterinary examination and was passed fit to start. A post-race veterinary examination revealed no visible abnormalities.

**ALASKAN JADE** (J. Holder) - laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

**NON PAEAR** (C. Caserta) - raced keenly in the early stages of the event.

**KABINI** (D. Tourneur) - shifted out at the start and contacted **ZAGATO STAR**.

**ZAGATO STAR** (C. Parish) - shifted in at the start and contacted **KABINI**.

**JUST PEGGY** (R. Clark) - raced keenly in the early stages of the event.

**RACE 4: TAB ADELAIDE CUP - MARCH 11 AT MORPHETTVILLE HANDICAP - 1200 metres**

**COCKLES** (C. Parish) - rider accidentally struck **AUSSIE JACK** with his whip inside the 100 metres.

**AUSSIE JACK** (C. Hall) - raced keenly in the early stages of the event. Was accidentally struck by the whip of C. Parish inside the 100 metres and thereafter raced in restricted room between **COCKLES** and **BWUVA** until the finish.

**BWUVA** (T. Pannell) - held up for clear running from inside the vicinity of the 400 metres until the 300 metres.

**VIETTI** (J. Holder) - raced keenly in the early stages of the event.

**RACE 5: TERRY HOWE PRINTING HANDICAP - 1050 metres**

**MIHANY** (C. Caserta) - was severely hampered for several strides shortly after the start by **SIRBIBLE** which took charge and shifted in abruptly. As a consequence, had to be checked and lost its position.

**ZALMONA** (T. Pannell) - awkward to begin. Raced ungenerously in the early stages of the event.

#### **RACE 5: TERRY HOWE PRINTING HANDICAP - 1050 metres (cont'd)**

**SIRBIBLE** (R. Hurdle) – shortly after the start took charge of its rider, shifted in very abruptly hampering **BAROOD**, which had to be steadied. Then shifted in further severely hampering **PORT VALE** for several strides, which had to be checked losing its position and thereafter continued to shift in towards the inside fence severely hampering **MIHANY** for several strides, which had to be checked losing its position. Following this incident **SIRBIBLE** continued to race very ungenerously, placing its rider at a disadvantage, until near the 600 metres. Rider explained that the gelding took charge shortly after the start and as a consequence he had difficulty steering his mount. Trainer, Mr D. Tootell, was advised that in view of the gelding's racing manners it was now suspended and must complete an Official Barrier Trial to the Stewards' satisfaction prior to its next race start. A post-race veterinary examination revealed no visible abnormalities.

**BAROOD** (E. Finnegan) – hampered shortly after the start by **SIRBIBLE**, which shifted in abruptly, and had to be steadied.

**PORT VALE** (O. Ridge) – shortly after the start was severely hampered by **SIRBIBLE**, which shifted in abruptly, had to be checked for several strides and lost its position. A post-race veterinary examination revealed no visible abnormalities.

**TINTAGEL ROCKER** (D. Tourneur) – rider reported that the gelding felt sore in the off foreleg on pulling up. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr J. Dunn, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

#### **RACE 6: HOLDFAST INSURANCE HANDICAP - 1800 metres**

**STRATEGIC DEMAND** (K. Crowther) – laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

**LITTLE WHITE CLOUD (IRE)** (J. Potter) – a post-race veterinary examination revealed no visible abnormalities.

**MELI MELO** (J. Holder) – rider explained that the mare raced a little keenly in the early stages of the event, travelled well thereafter but knocked up over the concluding stages and he was of the view that it may benefit from the run. A post-race veterinary examination revealed no visible abnormalities.

**HIPPARCHUS (GB)** (H. Coffey) – rider explained his instructions were to lead. He added that the horse found the lead with relative ease, but was one paced and extended its lead mid-race, and whilst he was conscious of having extended the margin with the field he was reluctant to restrain his mount at that stage of the event as he considered it may have disrupted the horse's momentum.

#### **RACE 7: DOMINANT HANDICAP - 2049 metres**

**EXCESSABEEL (NZ)** (C. Hall) – approaching the 1800 metres shifted in and crossed the running of **BILLET DOUX**, which was inconvenienced. Rider reminded of her obligations when shifting ground.

**BILLET DOUX** (D. Tourneur) – approaching the 1800 metres was inconvenienced when crossed by **EXCESSABEEL (NZ)**. Raced wide without cover in the early and middle stages of the event. Laid in for a short distance near the entrance to the straight. A post-race veterinary examination revealed no visible abnormalities.

**DR DEPENDABLE** (R. Clark) – got loose in the stall area prior to presenting in the mounting yard. Underwent a pre-race veterinary examination and was passed fit to start.

**RACE 7: DOMINANT HANDICAP - 2049 metres (cont'd)**

**CONVERGING** (J. Holder) - over-raced in the early stages of the event. Laid in, in the early part of the straight.

**EPERDUMENT** (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 8: JAMES BOAG'S HANDICAP - 1600 metres**

**ENKI** (D. Caboche) - near the 1100 metres was hampered by JACKTHEGIANTSLAYER as that horse was severely hampered due to the pace slowing. Lost its off hind plate during the event.

**NASEEB** (C. Caserta) - contacted at the start. Near the 1100 metres was hampered when awkwardly placed on the heels of ENKI when the pace slowed. Thereafter raced keenly in the middle stages of the event.

**CANFORD** (T. Pannell) - contacted at the start. A post-race veterinary examination revealed no visible abnormalities.

**MARINA** (H. Grace) - near the 1100 metres became awkwardly placed on the heels of CANNOT BE SERIOS (NZ) as the pace slowed and became ungenerous and was severely hampered for several strides.

**CANNOT BE SERIOS (NZ)** (C. Hall) - shifted in shortly after the start and contacted CANFORD. Near the 1100 metres shifted in across the running of MARINA, and after taking up a position on the rail slowed the paced excessively. As a consequence, MARINA, which was following, became very awkwardly placed on the heels of CANNOT BE SERIOS (NZ) for several strides. Further as a consequence of this incident JACKTHEGIANTSLAYER, which was following became awkwardly placed on the heels of MARINA, and was severely hampered for several strides. Rider found guilty of a charge under AR137(d) in that she excessively slowed the speed of her horse, causing direct and indirect interference, and was suspended from riding in races for a period to commence midnight Wednesday, 23 January 2019 and to conclude midnight Monday, 28 January 2019, a period of four race meetings.

**PICTURE ME ROLLING** (R. Clark) - awkward to begin, shifted out and contacted NASEEB. Raced ungenerously for a short near the 900 metres.

**JACKTHEGIANTSLAYER** (E. Finnegan) - near the 1100 metres became awkwardly placed on the heels of MARINA for several strides, and was hampered, as that horse became awkwardly placed for several strides on the heels of CANNOT BE SERIOS (NZ) as the pace slowed.

**SUPERVELOCE (NZ)** (K. Crowther) - near the 1100 metres was hampered due the pace slowing in front.
