Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Saturday, 9 February 2019

RACE 1: AAMI HANDICAP - 2500 metres

LAST ONE NAMED (E. Finnegan) – rider reported that the gelding commenced to hang out from the vicinity of the 1600 metres and she had become concerned with its action over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

MAJESTIC RIDGE (C. Hall) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: FLEURIEU MILK COMPANY HANDICAP - 1543 metres

BLUE HOPE (J. Mott) - laid out under pressure over the concluding 100 metres of the event.

SIR GARFIELD (R. Hurdle) - laid in under pressure in the straight.

SMALL SCALE (C. Caserta) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

ST GEORGES VAULTS (J. Toeroek) - laid in under pressure in the straight.

RACE 3: TAB ADELAIDE CUP - MARCH 11 AT MORPHETTVILLE HANDICAP - 1600 metres

LIEDER (S. Cahill) - inclined to lay in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: TAB ADELAIDE CUP - MARCH 11 AT MORPHETTVILLE HANDICAP - 1600 metres (cont'd)

NASEEB (C. Caserta) – raced in restricted room from the entrance to the straight until approaching the 100 metres when awkwardly placed between the heels of OUTINTHESTREET and SILENT ICE. Accidentally struck in the vicinity of the head by the whip of OUTINTHESTREET on two occasions approaching the 100 metres and inside the 100 metres shifted out and away abruptly inconveniencing SILENT ICE, which was taken wider. Rider explained that the gelding was reluctant to improve into a tight run in the straight; however, after finding clear galloping room inside the 100 metres had finished the race off strongly.

SILENT ICE (K. Crowther) - inclined to lay in under pressure in the straight. Taken wider inside the 100 metres by NASEEB.

EXALTED LAURETTA (J. Holder) - had difficulty obtaining clear ground from the entrance to the straight until approaching the 200 metres. Lost its off fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: HOLDFAST INSURANCE HANDICAP - 1600 metres

BALF'S CHOICE (C. MacFarlane) - had difficulty obtaining clear ground from the vicinity of the 500 metres until the entrance to the straight.

MORVADA (J. Toeroek) - lost its off hind plate during the event.

KAZOOM (NZ) (M. Henderson) - stood flat-footed and missed the start several lengths. Trainer, Mr R. Campbell, was advised that the gelding would be required to jump away with the field in an Official Barrier Trial prior to a future race start. Rider reported that after missing the start the gelding was reluctant to race despite his efforts throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: WINNING EDGE PRESENTATIONS HANDICAP - 1200 metres

CROWN FONTEIN (R. Clark) - raced greenly throughout the event. Laid out under pressure in the straight.

KABINI (D. Tourneur) - laid out under pressure in the straight.

Correct weight for this event was delayed to allow J. Huxtable (AMBERDI), placed second, to view the vision over the concluding 800 metres.

RACE 6: NUTELLA PALOOZA - APRIL 20 AT MORPHETTVILLE RACECOURSE HANDICAP - 1200 metres

The start of this event was delayed approximately three minutes.

BY THE POUND (S. Price) – proved extremely difficult to load. Trainer, Mr W. Bencic, was advised that the gelding would be required to load without delay in an Official Barrier Trial prior to a future race start.

TAMBANG BESI (K. Crowther) - laid in under pressure in the straight.

SURREAL IMAGE (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

BEHAVE (J. Toeroek) - had difficulty obtaining clear ground for a short distance on entering the straight.

RACE 6: NUTELLA PALOOZA - APRIL 20 AT MORPHETTVILLE RACECOURSE HANDICAP - 1200 metres (cont'd)

KEEMON (E. Finnegan) - hung out throughout the event. Trainer, Mr G. Searle, was advised that a warning had been placed on the gelding in relation to its racing manners. A post-race veterinary examination revealed no visible abnormalities.

MARIANNE RUBY (C. Hall) - slow into stride. A post-race veterinary examination revealed no visible abnormalities.

DATURA (C. MacFarlane) - in the vicinity of the 300 metres was disappointed when attempting a tight run to the inside of KEEMON, and had to be checked.

THRONES (C. Caserta) - a post-race veterinary examination revealed no visible abnormalities.

RACE 7: HAPPY 60TH PETER GRAETZ HANDICAP - 1050 metres

IDATWO (S. Price) - lost its near fore plate during the event.

KILOWATT (C. Caserta) - inclined to rear on jumping away. Inside the 100 metres was contacted by BRIS VEGAS.

DOMINATION (J. Holder) - raced keenly in the early and middle stages of the event.

BRIS VEGAS (C. MacFarlane) - slow to begin. Hung in throughout the event. In the vicinity of the 100 metres shifted in and contacted KILOWATT. Stewards questioned C. MacFarlane in relation to her riding of this gelding approaching the 100 metres and in particular leading up to her contacting KILOWATT. After considering her explanation Stewards advised C. MacFarlane that she would be given the benefit of a very grave doubt in relation to whether her actions were intentional. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer, Mr R. Balfour, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

MUSICAL QUERY (L. Doodt) – struck a perimeter fence on exiting the mounting yard. Underwent a pre-race veterinary examination on arrival at the barriers and found to have a laceration to the off side rump and to be unfit to race. Acting on this advice Stewards withdrew MUSICAL QUERY at 5.07 pm.

FRANCE'S BOY (R. Clark) - laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

SHES GOT THE GOODS (D. Caboche) - slow into stride.

RACE 8: KILLER QUEEN EXPERIENCE - FEB 9 AT MORPHETTVILLE HANDICAP - 1800 metres

CABLE BAY (NZ) (J. Potter) - raced wide without cover throughout the event.

FRANKED (GB) (C. Hall) - raced keenly in the middle stages of the event.

JACKTHEGIANTSLAYER (E. Finnegan) - a post-race veterinary examination revealed no visible abnormalities.

WALTZING WODKA (C. Caserta) - Mr J. Cornell, representing trainer Mr T. McEvoy, advised Stewards of a change of tactics in that he would instruct the rider to attempt to obtain a position more forward in this event than previous starts. In the vicinity of the 1200 metres had to be steadied momentarily when it improved onto the heels of LOSTARC as the pace eased slightly.

RACE 8: KILLER QUEEN EXPERIENCE - FEB 9 AT MORPHETTVILLE HANDICAP - 1800 metres (cont'd)

LOSTARC (C. MacFarlane) - laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

FLYING TORMENTA (K. Bishop) - rider accidentally dropped her whip in the vicinity of the 400 metres. Laid out under pressure in the straight.

COSMIC CHARM (D. Tourneur) – a post-race veterinary examination revealed a minor laceration to the near fore cannon, First aid applied.

TIZA (K. Crowther) - slow to begin.

GRABBING GLORY (R. Clark) - slow to begin.
