Report on Race Meeting held at Penola Racecourse

RACE 1: FESTIVAL HIRE / SABOIS MAIDEN PLATE - 1700 metres

ILLOWA (J. Huxtable) - raced greenly throughout the event. Hung in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

TARDIGRADE (D. Caboche) - Trainer, Mr M. Seyers, was reprimanded under AR59A for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by the Stewards. In assessing penalty Stewards took into account that Mr Seyers had never been spoken to under this Rule.

RACE 2: COOPERS BREWERY / SABOIS MAIDEN PLATE - 1100 metres

SANDHILL HUSTLE (P. Marks) - jumped away awkwardly and shifted out.

HASTA LA DREAMS (C. Caserta) - marginally slow to begin and shortly after was unable to improve its position due to SANDHILL HUSTLE jumping away awkwardly and shifting out into the running line of the gelding. A post-race veterinary examination revealed the gelding to be shin sore in both forelegs. Trainer, Ms S. Murphy, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

PRESS ON (D. Tourneur) - raced tight for a short distance in the vicinity of the 400 metres between WISHIA and SHIKOVA, which rolled in.

SHIKHOVA (J. Lorensini) - jumped away awkwardly. In the vicinity of the 400 metres rolled in onto PRESS ON.

RACE 3: TAB / SABOIS MAIDEN PLATE - 1300 metres

MR TOOLONG (J. Huxtable) - lost its position on jumping away when MUCKUP jumped away awkwardly, shifted out and contacted the gelding tightening it onto ROYAL LA BELLE.

MUCKUP (D. Tourneur) - jumped away awkwardly and shifted out contacting MR TOOLONG.

TONTEIN (D. Bates) - acting on a confirmed telephone call from Trainer, Mr R. Bruhn, that the gelding was unfit to race Stewards withdrew TONTEIN at 12.01 pm. Mr Bruhn was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

BLAME RODNEY (J. Maund) - raced keenly in the early and middle stages of the event.

HOWEXCITING (D. Smith) - jumped away awkwardly. Rider pleaded guilty to a charge under AR137A(5)(a)(i) in that he used his whip in consecutive strides and was reprimanded. Rider also pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200. In assessing penalty Stewards took into account D. Smith had never been spoken to under this Rule and his relative inexperience riding in Australia.

RACE 4: BAXTER HIRE BENCHMARK 64 HANDICAP - 1400 metres

IAMTHEKEY (J. Huxtable) - jumped away awkwardly. Laid in under pressure in the straight.

MR SINATRA (L. Williams) - stood flat-footed and was slow to begin. Ms H. Place, stable representative for trainer, Mr D. Daffy, was advised that a warning had been placed on the gelding in relation to its starting manner.

LONRUSE (D. Bates) - raced wide without cover throughout the event. Rider explained that the gelding travelled well during the event even though he was caught wide without cover. He added that once he placed LONRUSE under pressure in the vicinity of the 500 metres the gelding failed to respond to his riding and was disappointing in its efforts to the finish. A post-race veterinary examination revealed no visible abnormalities.

MR BOTTERILL (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

RACE 5: THE MIDFIELD GROUP SUMMER CUP - 2100 metres

TRENDSETTER (NZ) (J. Lorensini) - at the entrance to the straight rolled out and brushed STRATEGIC GLASS. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

STRATEGIC GLASS (E. Finnegan) - at the entrance to the straight brushed with TRENDSETTER (NZ), which rolled out.

ATHOS (C. Puls) - jumped away awkwardly and as a result was slow to begin.

BASSONS (D. Tourneur) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

DANGEROUS REBEL (J. Maund) - over-raced throughout the event. Weakened from approaching the 400 metres. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr M. O'Leary, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

RACE 6: KATNOOK ESTATE BENCHMARK 64 HANDICAP - 1100 metres

REDEEKA (D. Bates) - in the vicinity of the 100 metres was taken in by UNIVERSAL THIEF, which was inclined to lay in and shifted in.

UNIVERSAL THIEF (J. Maund) - laid in under pressure in the straight and in the vicinity of the 100 metres shifted in onto REDEEKA, which was taken in.

MONTRE (K. Bishop) - dipped shortly after the start unbalancing its rider for a short distance.

THE OTHER GUY (C. Puls) - held up for clear running from in the vicinity of the 400 metres until inside the 200 metres where it was obliged to shift out.

UNYIELDING (J. Lorensini) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: ADRIAN THOMAS INDUSTRIAL BENCHMARK 56 HANDICAP - 1700 metres

CENTENARY SHOT (G. Lo) - in the vicinity of the 100 metres elected to shift to the inside of PEWTER, which was inclined to lay out, to obtain clear running.

PEWTER (C. Caserta) - laid out under pressure in the straight.

SHOOSHKABOB (S. Cahill) - on jumping away was tightened onto PEWTER as STRATEGIC SPICE jumped away awkwardly and shifted out.

DISCO REBEL (J. Lorensini) - stood flat-footed and was slow to begin. Stable foreperson, Mr B. Jaensch, representing trainer Mrs S. Jaensch, was advised that a warning had been placed on the mare in relation to its starting manners. Held up for clear running from the 400 metres until inside the 200 metres.

STRATEGIC SPICE (J. Maund) - jumped away awkwardly and shifted out onto SHOOSHKABOB. Approaching the 1100 metres bumped with NORMANDY LAD, which was racing fiercely and shifted out. Held up for clear running from in the vicinity of the 400 metres until in the vicinity of the 200 metres and was hampered when GO WALLY rolled in and as a result STRATEGIC SPICE became awkwardly placed on the heels of DUCK DYNASTY (NZ). Rider explained that after being hampered inside the 200 metres he was unable to improve into a run that presented between GO WALLY and DUCK DYNASTY (NZ) as his mount hung in and as a result he was unable to ride his mount out. From inside the 100 metres was held up for clear running until the finish of the event. A post-race veterinary examination revealed no visible abnormalities.

NORMANDY LAD (C. Puls) - raced fiercely throughout the event. Approaching the 1100 metres when being restrained rolled out and bumped STRATEGIC SPICE.

DADDY'S LITTLELADY (D. Caboche) - had difficulty obtaining clear running from the entrance of the straight until in the vicinity of the 100 metres when racing inside of TZAREVNA.

GO WALLY (W. Cave) - in the vicinity of the 200 metres bumped with STRATEGIC SPICE.
