

THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 23 February 2019

RACE 1: MYPUNTER.COM HANDICAP - 1000 metres

DAWN SALUTE (K. Crowther) - shifted out on jumping away contacting UTZON (NZ). Raced in restricted room from the vicinity of the 300 metres until inside the 200 metres when it was steadied and obliged to alter course to obtain clear ground. Inclined to lay in over the concluding stages.

GUARDIAN (C. Jones) - raced in restricted room in the vicinity of the 250 metres for a number of strides when awkwardly placed between the heels of KALMAR and MAGIC DEE, which rolled in slightly.

THE EXECUTIONER (J. Holder) - jumped away awkwardly and was slow into stride. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

KALMAR (J. Toeroek) - laid out rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

MAGIC DEE (J. Potter) - inconvenienced on jumping away when UTZON (NZ) was taken out into the filly's running line.

RACE 2: 13CABS HANDICAP - 1550 metres

MIHANY (C. Caserta) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

CHIVADAHLII (G. Cartwright) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded. **MISTA HOLYFIELD** (R. Clark) - difficulty obtaining clear ground from the entrance to the straight until in the vicinity of the 200 metres when awkwardly placed between the heels of MIHANY and FULTON STREET.

FULTON STREET (J. Toeroek) - raced keenly in the early and middle stages of the event. A postrace veterinary examination revealed no visible abnormalities.



RACE 3: STEVE ELLIS'S 40TH HANDICAP - 2400 metres

OLYMPIC ACADEMY (J. Huxtable) - laid out rounding the home turn and under pressure in the straight. Rider explained he was instructed to have the gelding in a position where comfortable, however, if there was no speed in the race to allow the gelding to slide forward and lead. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

AZURITE (IRE) (C. Caserta) - Trainer reprimanded under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards. Trainer advised that the TIC must be poduced prior to future race start. Raced keenly in the early and middle stages of the event.

CATCH THE CULPRIT (R. Clark) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

FRANKED (GB) (C. Hall) - raced keenly in the early and middle stages of the event. Laid out rounding the home turn and under pressure in the straight.

PAT THE WEAPON (Z. Spain) - raced keenly in the early and middle stages of the event. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 4: HIT107 HANDICAP - 1250 metres

LUCKY FLIPPER (A. Jordsjo) - in the vicinity of the 1000 metres got it head up whilst being restrained when gaining cover behind RHYTHMATIC.

EXALTED TRAVELLER (R. Clark) - raced keenly in the early and middle stages of the event. Laid in under pressure in the straight. Rider reported the gelding travelled well in the early and middle stages, however when placed under pressure at the entrance to the straight, failed to respond to her riding and was disappointing to the finish. A post-race veterinary examination revealed no visible abnormalities.

DIAPASON (NZ) (J. Holder) - laid out under pressure in the straight.

RACE 5: TAB ADELAIDE CUP - MARCH 11 AT MORPHETTVILLE HANDICAP - 1000 metres

TILDY LAD (A. Jordsjo) - wide without cover throughout the event.

ZALMONA (G. Cartwright) - jumped away awkwardly.

FANCY RUMBLE (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

MUSICAL QUERY (Z. Spain) - raced keenly in the early and middle stages of the event. A postrace veterinary examination revealed the gelding to be lame in the off foreleg. Trainer Mr M. Minervini was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

QUIDDICK (J. Toeroek) - became fractious and dislodged its rider whilst being loaded. Underwent a pre-race veterinary examination and passed fit to race. Laid out over the concluding 400 metres.

RACE 6: SCHWEPPES HANDICAP - 1400 metres

HOLY COMMAND (Z. Spain) - lost its near fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.



RACE 6: SCHWEPPES HANDICAP - 1400 metres (Cont'd)

CANNOT BE SERIOS (NZ) (C. Hall) - raced keenly in the early and middle stages of the event. Lost its off hind plate during the event.

DANGER DEAL (R. Clark) - slow to begin. A post-race veterinary examination revealed the gelding to be lame in both forelegs. First aid administered. Co-Trainer Mr L. Macdonald was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

ENKI (C. Caserta) - unable to obtain clear ground from the entrance to the straight until approaching the 50 metres.

MOGHUL EMPIRE (J. Toeroek) - raced keenly in the early and middle stages of the event.

KNOTTED (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

MISS CUOCO (E. Finnegan) - rider reported in her opinion the mare felt sore behind. A post-race veterinary examination revealed the mare to be lame in the near hind leg. Trainer Mr G. Searle was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

RACE 7: ADELAIDE GALVANISING HANDICAP - 1400 metres

SUPER (J. Holder) - in the vicinity of the 300 metres had to take hold and lost its position when tightened onto KEMALPASA by TONGSAI BOSS, which had been taken out.

TONGSAI BOSS (J. Toeroek) - in the vicinity of the 300 metres was taken out into the running line of SUPER by COTILLION.

DREAMED (D. Tourneur) - became awkwardly placed on the heels of TONGSAI BOSS for a short distance at the entrance to the straight.

SIR JOHNSON (E. Finnegan) - jumped away awkwardly and shifted out onto COTILLION.

COTILLION (C. Hall) - in the vicinity of the 300 metres shifted out onto TONGSAI BOSS taking that gelding out onto SUPER, which was forced to take hold when tightened onto KEMALPASA. Rider pleaded guilty to a charge of careless riding under AR137(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 2 March and to conclude at midnight on Sunday, 10 March 2019: a period of four meetings.

GONE TO PRINT (G. Cartwright) - jumped away awkwardly.

RACE 8: WINNING EDGE PRESENTATIONS HANDICAP - 1400 metres

OUR BENEVENTO (J. Holder) - jumped away awkwardly.

GOUGERS (A. Jordsjo) - raced keenly in the early and middle stages of the event.

TURF TAPPER (R. Hurdle) - shifted out on jumping away onto BEHAVE.

DAYS GO BY (FR) (K. Bishop) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was fined \$100.

BEHAVE (J. Toeroek) - contacted on jumping away. Raced keenly in the early and middle stages of the event.

Correct weight was delayed to allow J. Toeroek, rider of BEHAVE, the second placed horse, to view the photo image for first.
