Report on Race Meeting held at Bordertown Racecourse

**RACE 1: MAX FRYAR MEMORIAL / SABOIS MAIDEN PLATE - 1100 metres**

**HANLON TIGER** (P. Marks) - rolled in, in the vicinity of the 900 metres tightening SANDHILL GALAXY. At the entrance to the straight shifted out and away from NEVER SHORT, tightening the running of SANDHILL GALAXY.

**SANDHILL GALAXY** (K. Bishop) - raced keenly in the early and middle stages of the event. In the vicinity of the 900 metres tightened by HANLON TIGER, which rolled in. Difficulty obtaining clear ground from the 400 metres until the entrance to the straight and shortly thereafter tightened and lost its position between MISS ASTRONOMOORE and HANLON TIGER, which shifted out.

**CANIDAE** (S. Fawke) - jumped away awkwardly. Laid in, in the straight.

**COUNTRY COP** (J. Lorensini) - jumped away awkwardly.

**NEVER SHORT** (J. Huxtable) - laid out in the straight. A post-race veterinary examination revealed no visible abnormalities.

**MISS ASTRONOMOORE** (S. Tsaiikos) - jumped away awkwardly.

**RACE 2: BORDERTOWN STONE SUPPLIES / SABOIS MAIDEN PLATE - 1550 metres**

**CHEEKYS BRO** (E. Boyd) - raced keenly in the early and middle stages of the event.

**GUEST LIST** (G. Lo) - became awkward in its action approaching the 600 metres. Rider dropped his whip inside the 200 metres.

**RACE 2: BORDERTOWN STONE SUPPLIES / SABOIS MAIDEN PLATE - 1550 metres (Cont'd)**

**KIAMA LIGHTHOUSE (NZ)** (E. Finnegan) - laid in throughout the event. In the vicinity of the 1200 metres shifted in tightening the running of SAYEDDA. A post-race veterinary examination revealed no visible abnormalities.

**TATTIES** (D. Tourneur) - laid in, in the straight. Inside the 100 metres shifted in tightening AZDAJA onto BEAR ARMS. Rider reminded of his obligations and advised to straighten his mounts sooner when they commence to shift ground.

**AZDAJA** (J. Lorensini) - approaching the 100 metres was inconvenienced by BEAR ARMS, which laid out. Inside the 100 metres tightened between BEAR ARMS and TATTIES resulting in AZDAJA being unable to be fully tested for the remainder of the event.

**SAYEDDA** (J. Maund) - tightened by KIAMA LIGHTHOUSE (NZ) in the vicinity of the 1200 metres, which laid in.

**BEAR ARMS** (C. Puls) - approaching the 100 metres laid out bumping AZDAJA. Inside the 100 metres inconvenienced by AZDAJA, which was taken in.

Correct weight was delayed to allow Paul Marks (RYZLINK) placed second and Trainer Mr J. MacMillan and fourth place getter C. Puls (BEAS ARMS) to view the vision in the straight.

**RACE 3: DON IRLAM MEMORIAL / SABOIS MAIDEN PLATE - 1300 metres**

**BLAZING HARADA** (S. Tsaikos) - jumped away awkwardly.

**DANDARBONG** (A. Lindsay) - rider explained she was instructed to ride the gelding back in the early stages. She added the gelding failed to respond to her riding over the final 200 metres.

**PUFTALOON** (P. Marks) - rider explained the gelding did not show its normal speed in the early part of the race therefore he was obliged to settle further back than intended.

**SANDHILL HUSTLE** (J. Lorensini) - jumped away awkwardly.

**HE WILL BOOM** (E. Finnegan) - raced keenly throughout the event. Laid out from the vicinity of the 400 metres until the entrance of the home straight. Whilst being corrected shifted in and tightened VIEW OF BLUE. Rider reminded of his obligations and advised to only shift ground when entitled to do so.

**VIEW OF BLUE** (J. Potter) - at the entrance to the home straight was tightened and lost its position between REVOLUTION BABY, which laid out and HE WILL BOOM, which shifted in.

**REVOLUTION BABY** (D. Tourneur) - at the entrance to the straight laid out tightening VIEW OF BLUE.

**RACE 4: WEBB CONTRACTORS BENCHMARK 64 HANDICAP - 1300 metres**

The start of this event was delayed approximately two minutes.

**GIGGLON** (J. Huxtable) - reared on jumping away and as a result was slow to begin.

**OLATUNJI** (J. Maund) - got its leg up after being loaded. Underwent a pre-race veterinary examination and passed fit to race.

**LONGMIRE** (J. Lorensini) - laid in, in the straight.

**MISS MOSH** (J. Potter) - had difficulty obtaining clear ground between the 400 metres and the 200 metres.

**RACE 4: WEBB CONTRACTORS BENCHMARK 64 HANDICAP - 1300 metres (Cont'd)**

**STREAK OF LIGHT** (E. Boyd) - stood flat-footed as the start was affected and as a result was slow to begin three lengths. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Mr S McIntyre was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**RACE 5: MICHELLE'S PET & HOME SERVICES BENCHMARK 64 HANDICAP - 2000 metres**

**STRATEGIC GLASS** (E. Finnegan) - a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Ms S. Jaensch was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**HASTA LA THOMAS** (C. Jones) - laid out rounding the home turn and in the straight.

**MARMAN** (S. Fawke) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**COSMIC CHARM** (D. Tourneur) - laid in, in the straight.

**RAZZLE DAZZLE ROCK** (K. Bishop) - in the vicinity of the 1700 metres raced in restricted room between STRATEGIC GLASS and COSMIC CHARM. Laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

**CASIRAGHI** (S. Logan) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 6: BORDER AG BENCHMARK 56 HANDICAP - 1100 metres**

**CURTAIN CALL** (J. Huxtable) - rider reported the gelding did not travel throughout the event and as a result finished the race off disappointingly. A post-race veterinary examination revealed atrial fibrillation. Trainer advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

**KLOSS** (S. Fawke) - in the vicinity of the 800 metres dipped and became awkward in its action for a number of strides. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Mr S. Gebert was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**UNYIELDING** (J. Lorensini) - raced keenly in the early and middle stages of the event. In the vicinity of the 800 metres was obliged to be eased when improving onto the heels of VEIN CHOICE.

Correct weight was delayed to allow J. Lorensini (UNYIELDING) placed equal second, to view the official photo finish.

**RACE 7: WILLOW GROVE STUD BENCHMARK 56 HANDICAP - 1550 metres**

**JACKTHEGIANTSLAYER** (G. Lo) - raced keenly in the early stages of the event.

**ARTISTIC DESIGN** (J. Huxtable) - inside the 200 metres shifted in when insufficiently clear and hampered REEF'S REVENGE. Rider severely reprimanded.

**SPOTAKOVA** (J. Maund) - raced wide throughout the event.

**CHALLICUM** (J. Potter) - raced keenly in the early and middle stages of the event.

**RACE 7: WILLOW GROVE STUD BENCHMARK 56 HANDICAP - 1550 metres (Cont'd)**

**MAJESTIC RIDGE** (E. Boyd) - rider reported the mare failed to respond to her riding from the 600 metres and had become concerned with its action in the straight and for this reason did not ride the mare out in her normal manner. A post-race veterinary examination revealed no visible abnormalities.

**REEF'S REVENGE** (A. Jordsjo) - laid in under pressure approaching the 200 metres. Inside the 200 metres was hampered by **ARTISTIC DESIGN**, which shifted in.

**HASTA LA SPEC** (S. Fawke) - laid out from the 400 metres until the finish. A post-race veterinary examination revealed no visible abnormalities.
