

#### THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Balaklava Racecourse by the Balaklava Racing Club on Sunday, 24 January 2019

## RACE 1: HAULMARK TRAILERS / SABOIS MAIDEN PLATE - 1050 metres

**HURRY HOME HARRY** (J. Toeroek) - lost its position approaching the 800 metres when KISSABLE EIGHT shifted in. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**NIC'S SECRET** (C. Caserta) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**STRICTLY MAMBO** (R. Hurdle) - when racing greenly approaching the 800 metres, shifted in and away from NIC'S SECRET onto KISSABLE EIGHT. Laid in under pressure in the straight.

**LOMON TEMBY** (D. Tourneur) - raced fiercely in the early and middle stages of the event. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**KISSABLE EIGHT** (E. Finnegan) - approaching the 800 metres shifted in and away from STRICTLY MAMBO onto HURRY HOME HARRY. Lost its off fore plate during the event. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded. Rider reported in her opinion the filly felt sore behind on pulling up. A post-race veterinary examination revealed no visible abnormalities.

**TAKE THE STAGE** (J. Holder) - inconvenienced in the vicinity of the 800 metres when HURRY HOME HARRY shifted in.

**TWICE FORGOTTEN** (S. Fawke) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

## RACE 2: COOPERS / SABOIS MAIDEN PLATE - 1400 metres

**ECLAIR FLAME** (GB) (G. Lo) - inclined to lay out in the early and middle stages. Laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**ABBI FEDE** (S. Fawke) - shifted out and away from ECLAIR FLAME (GB) when placed under pressure over the concluding 200 metres.

ELECTRUM (D. McWhinney) - a post-race veterinary examination revealed no visible abnormalities.



# RACE 2: COOPERS / SABOIS MAIDEN PLATE - 1400 metres (Cont'd)

**ORANGES** (K. Bishop) - Trainer, Mr A. Beswick advised Stewards that he would instruct his rider to attempt to obtain a position mid-field with cover rather than lead or be on pace as the mare had at its most recent starts. Raced keenly in the early and middle stages of the event. Had difficulty obtaining clear ground from the entrance to the straight until inside the 400 metres.

LADY YOUNG (J. Holder) - raced wide without cover throughout the event.

Correct weight was delayed to allow S. Fawke (ABI FEDE), which was a dead-heated for second place to view the vision in the straight. After doing so, he lodged an objection against ECLAIR FLAME being declared equal dead heat for second, alleging interference over the concluding 200 metres. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* the protest.

#### RACE 3: BALAKLAVA STITCH JOINT / SABOIS PLUS MAIDEN / CLASS ONE PLATE - 2200 metres

**RED VALENTINE (NZ)** (D. Tourneur) - slow to begin.

**SEATTLE SOUND** (J. Holder) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**HEZ A WOLF** (C. Jones) - raced keenly in the early and middle stages of the event. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

**HIERO** (C. Caserta) - approaching the 100 metres shifted in under pressure onto MANILOW. Rider reprimanded and advised in future to make a greater effort to keep his mounts straight when they commence to shift.

HUSSNING (R. Hurdle) - laid out under pressure in the straight.

**MANILOW** (J. Maund) - had to be steadied momentarily approaching the 100 metres when HIERO shifted in. A post-race veterinary examination revealed no visible abnormalities.

**RUN FOR SUCCESS** (J. Toeroek) - laid out from the vicinity of the 800 metres until the entrance to the straight.

BIG TOP (S. Fawke) - laid out from the vicinity of the 800 metres until the entrance to the straight.

HAVANA DEEJAY (NZ) (E. Finnegan) - rider explained the mare did not travel throughout the event and when placed under pressure in the vicinity of the 500 metres, had failed to respond to her riding and had been one-paced to the finish. A post-race veterinary examination revealed no visible abnormalities.

## RACE 4: HEINIGER / SABOIS FILLES & MARES BENCHMARK 64 HANDICAP - 1200 metres

**FLO JO SNIP** (S. Cahill) - jumped away awkwardly and shifted out bumping DUST 'N' DIAMONDS. Rider reported the mare had made excess respiratory noise on pulling up. A post-race veterinary examination revealed abnormal upper respiratory noise. Trainer advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

**COMMANDING DIVA** (J. Potter) - slow to begin.

JUST PEGGY (J. Toeroek) - raced keenly in the early and middle stages of the event.

**PANDEIA** (S. Logan) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was fined \$100.



## RACE 4: HEINIGER / SABOIS FILLES & MARES BENCHMARK 64 HANDICAP - 1200 metres (Cont'd)

**THE LORD'S LOOT** (K. Bishop) - slow to begin. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

## RACE 5: TAYLORS WINES BENCHMARK 60 HANDICAP - 1050 metres

WHITE JADE (R. Hurdle) - jumped away awkwardly. In the vicinity of the 200 metres was forced to take hold for a number of strides when attempting a run between NITRO MAGIC and PANAGIOTA, which rolled in slightly.

**BUNDLE O'DIAMONDS** (K. Bishop) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

NITRO MAGIC (G. Goomany) - a post-race veterinary examination revealed no visible abnormalities.

**PANAGIOTA** (D. Tootell) - inclined to shift about under pressure in the straight and approaching the 200 metres, rolled out slightly and in being corrected, shifted back in slightly onto WHITE JADE, which improved quickly to its inside. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer Mr D. Magro was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**PERFEK** (D. Tourneur) - slow to begin.

**COOLIDGE** (S. Logan) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

#### RACE 6: PLAINS PRODUCER CLASS ONE HANDICAP - 1200 metres

**BOHEMIAN FOREST** (J. Holder) - contacted in the vicinity of the 300 metres by EQUICHOI.

**SOUR CREAM** (S. Logan) - inclined to lay out under pressure in the straight.

**RUSHWA** (D. Tourneur) - shifted in shorlty after the start onto EQUICHOI. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**EQUICHOI** (J. Maund) - lost its position on jumping away. In the vicinity of the 300 metres shifted out in an attempt to improve and in doing so brushed BOHEMIAN FOREST for a short distance.

#### RACE 7: JOCKS PLATE BENCHMARK 56 HANDICAP - 1400 metres

MULLINGER LANE (J. Maund) - contacted on jumping away.

ZAGATO STAR (S. Price) - jumped away awkwardly. Held up from the entrance to the straight until the vicinity of the 200 metres.

**FEVER** - underwent a pre-race veterinary examination on arrival on course who reported the gelding had turned a plate en route to the course, had pricked its near fore hoof and would be unfit to race. Acting on this advice FEVER was a late scratching by order of Stewards at 3.36 pm.

**DATURA** - acting on confirmed advice from Trainer Mr R. Balfour that DATURA was lame in the off foreleg and unfit to race, the gelding was a late scratching at 7.38 am by order of Stewards.

**BETTERTHANYOU THINK** (R. Hurdle) - jumped away awkwardly and shifted out contacting MULLINGER LANE.

**MYOPIC** (J. Toeroek) - raced wide without cover throughout the event.



## RACE 7: JOCKS PLATE BENCHMARK 56 HANDICAP - 1400 metres (Cont'd)

**PARNOSSOS** (E. Boyd) - slow to begin and was eased from the event from the vicinity of the 600 metres. Rider reported that after being slow the gelding was reluctant to stretch out despite her efforts and failed to tack on the back of the field. She added after placing PARNOSSOS under pressure in the vicinity of the 600 metres, it commenced to weaken of its own accord and for this reason she had elected to stop riding and eased the gelding from the event. A post-race veterinary examination revealed the gelding to be lame in both forelegs. Trainer Mr M. Moosha was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**VOD** (D. McWhinney) - laid in under pressure in the straight. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**STAR MOVER** (C. Caserta) - raced keenly in the early and middle stages of the event. Had difficulty obtaining clear ground from the entrance to the straight until the vicinity of the 200 metres.

BALZAC (C. Lions) - jumped away awkwardly and was slow to begin.

**GRANDMASTER DASH** (K. Lau) - raced wide without cover throughout the event.
