
THOROUGHBRED RACING S.A. LIMITED
STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Bordertown Racecourse
by the Bordertown Racing Club on Sunday, 3 March 2019

Stewards: J. Adams (A/ Chairman), M. Williams (F) & D. Cookson (HT) (Stewards), J. Foster (Deputy Steward), Dr D. Goulding (Veterinary Surgeon).

TRACK: Good 4 (Track with some give in it)
(Downgraded at 11.29 to Soft 7 from the 1600 metres to 1300 metres, Good 4 remainder) (More rain affected track that will chop out)

RAIL: True

WEATHER: Fine

RACE 1: MORNING LOAF BAKERY / SABOIS MAIDEN PLATE - 1550 metres

ABBI FEDE (S. Fawke) - raced greenly when placed under pressure in the straight.

BUJOLASS (J. Maund) - when questioned regarding the performance of the mare rider stated that BUJOLASS failed to travel at any stage of the event and in his opinion may have resented the tongue-tie. A post-race veterinary examination revealed no visible abnormalities.

VIEW OF BLUE (S. Logan) - raced wide without cover throughout the event.

BEAR ARMS (E. Boyd) - over-raced in the early and middle stages of the event.

REVOLUTION BABY (D. Tourneur) - when questioned regarding the performance of the filly rider stated that his mount travelled well in the early and middle stages of the event but when placed under pressure from the vicinity of the 400 metres failed to respond to his riding and ran to the line in a disappointing manner. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: MICHELLE'S PET & HOME SERVICES / SABOIS MAIDEN PLATE - 1100 metres

BEERMINT (J. Huxtable) - dislodged its rider en route to the barriers and galloped a short distance before being recaptured. Underwent a pre-race veterinary examination and was passed fit to start. J. Huxtable was examined by the First Care Medical personnel and passed fit to fulfil his engagements. Difficult to load. Fractious in the barriers, reared as the start was effected and as a result was slow into stride. Trainer, Ms H. Lehmann, was advised that BEERMINT would be required to perform to the satisfaction of Stewards in an Official Barrier Trial prior to a future race start.

ANJAH (K. Bishop) - rider reported that her mount hung out in the vicinity of the 1000 metres and became awkwardly placed on the heels of LIVELY LASS. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$200.

LIVELY LASS (C. Lions) - approaching the finish shifted in and away from CENTRE SCOOTA.

RACE 3: UPPER SOUTH EAST LIQUID WASTE / SABOIS MAIDEN PLATE - 1300 metres

NOTARBARTOLO (J. Maund) - when questioned regarding the performance of the gelding rider explained that after beginning awkwardly with its head in the air, NOTARBARTOLO attempted to bound on a number of occasions and shifted in abruptly. He further explained that as a result he restrained his mount and it took no competitive part in the event. Stewards noted his explanation but advised that the inquiry would be adjourned to a time and date to be fixed to allow Stewards to examine betting records on the race and interview trainer, Ms K. Mooney. A post-race veterinary examination revealed no visible abnormalities. Trainer, Ms K. Mooney, was advised that the gelding was now required to perform to the Stewards' satisfaction in an Official Barrier Trial prior to a future race start.

CANIDAE (S. Fawke) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 4: TATIARA CARPET CLEANING BENCHMARK 56 HANDICAP - metres

BRYBECK (S. Logan) - in the vicinity of the 500 metres had to be restrained after improving onto the heels of BEL MOSHE.

EUDORA (C. Jones) - over-raced in the early and middle stages of the event.

RACE 5: D & M RURAL BENCHMARK 64 HANDICAP - 1100 metres

KNOTTED (S. Logan) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

MONTRE (K. Bishop) - slow to begin.

RACE 6: WILLOW GROVE STUD BENCHMARK 64 HANDICAP - 1550 metres

HURRICANE SONNY (S. Logan) - over-raced in the early stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$100.

RACE 7: RAY WHITE BENCHMARK 60 HANDICAP - 2000 metres

MARMAN (S. Fawke) - in the vicinity of the 200 metres was contacted by HASTA LA SPEC and taken wider on the track. Laid out under pressure over the concluding stages.

HAKERAK (S. Logan) - underwent a pre-race veterinary examination which revealed the gelding to be lame in the near hind leg. Acting on this advice Stewards withdrew HAKERAK at 3.05 pm. Mr G. Lynch, representing trainer Mr G. Young, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start.

GANGSTER'S RUN (C. Jones) - trainer, Mr D. O'Leary, advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to lead in today's event. Settled behind the leaders. When questioned regarding GANGSTER'S RUN not leading in today's event rider stated that after beginning well she was pressured in the early stages of the event by HASTA LA SPEC, which was looking to cross, and was mindful not to place GANGSTER'S RUN under full pressure in the early stages of the event bearing in mind the distance of the race, and for this reason she had elected to allow HASTA LA SPEC to cross her.

ARTISTIC DESIGN (K. Bishop) - held up for clear running from the 500 metres until inside the 400 metres.

RACE 7: RAY WHITE BENCHMARK 60 HANDICAP - 2000 metres (cont'd)

HASTA LA SPEC (D. Tourneur) - passing the 200 metres shifted out and contacted **MARMAN**.

REEF'S REVENGE (E. Boyd) - held up for clear running from the 500 metres until inside the 400 metres.
