### RACE 1: BAROSSA FINE FOODS HANDICAP - 1550 metres

**SO WE ARE** (T. Pannell) - laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

**ALLUSION** (J. Holder) - rider could offer no explanation for the gelding's performance, however was of the view that it may be better suited to racing over more ground. A post-race veterinary examination revealed no visible abnormalities.

## RACE 2: TAB HANDICAP - 1000 metres

ROSE TIARA (Z. Spain) - raced greenly during the event.

**DAWN SALUTE** (J. Toeroek) - laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

KALMAR (T. Pannell) - laid out over the concluding stages.

### RACE 3: AAMI THREE-YEAR-OLD MAIDEN PLATE - 1300 metres

BIG BUDS (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

**COUNTRY COP** (J. Toeroek) - held up for clear running at various stages in the straight and as a consequence, was unable to be fully tested to the line.

KNEE SLAPPER (E. Finnegan) - slow to begin.

OLIVE GROVE (Z. Spain) - raced wide without cover from near the 800 metres.

### RACE 3: AAMI THREE-YEAR-OLD MAIDEN PLATE - 1300 metres (cont'd)

**SPIRIT OF CHARM** (R. Hurdle) - laid out in the straight, shifted out and inconvenienced COUNTRY COP inside the 100 metres. Rider reprimanded for shifting ground when insufficiently clear.

BECHARM (T. Pannell) - awkward to begin.

**CHARMIST** (J. Holder) - raced keenly in the early and middle stages of the event. Rider reported the filly felt ordinary in its action. A post-race veterinary examination revealed no visible abnormalities.

**DELUXE DESIGN** (J. Potter) - held up for clear running from the entrance to the straight and was only able to be tested over the concluding 50 metres of the event after shifting ground outwards to obtain clear running.

# RACE 4: NUTELLA PALOOZA - APRIL 20 AT MORPHETTVILLE RACECOURSE HANDICAP - 2400 metres

**ROCKARRAL** (J. Holder) - lost is near fore plate during the event.

**CABLE BAY (NZ)** (J. Potter) - rider reminded of obligations regarding the use of his whip when his mounts are out of contention.

**GETTING LEGGIE** (Z. Spain) - a post-race veterinary examination revealed no visible abnormalities.

**ALL WELL (IRE)** (K. Bishop) - rider reminded of obligations regarding the use of her whip when her mounts are out of contention.

#### RACE 5: TAB ADELAIDE CUP - MARCH 11 AT MORPHETTVILLE HANDICAP - 1400 metres

GO THE JOURNEY (C. Jones) - over-raced in the early stages of the event.

HOLY COMMAND (Z. Spain) - when questioned regarding his instructions and his riding over the concluding stages, rider explained he was instructed to allow the gelding to roll forward. He added the gelding appeared to change stride on a number of ocassions early in the event and was proppy in running. He stated that near the 100 metres the gelding had come to the end of its run and he was of the view it could not further improve its position and for that reason eased up on his riding. Rider pleaded guilty to a charge under AR131(b) for failing ro ride his horse out to the end of the race and was fined \$200. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Mr M. Price was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**ROSELLI STING** (G. Cartwright) - laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

#### RACE 6: ELTON JOHN EXPERIENCE - JULY 27 AT MORPHETTVILLE HANDICAP - 1000 metres

**EXTREME THRILL** (J. Eaton) - a post-race veterinary examination revealed no visible abnormalities.

WHITE KAPS (J. Martin) - knuckled severely at the start. A post-race veterinary examination revealed no visible abnormalities.

**IN HEART'S WAKE** (G. Cartwright) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using her whip on more than five occasions prior to the 100 metres and was reprimanded.

# RACE 6: ELTON JOHN EXPERIENCE - JULY 27 AT MORPHETTVILLE HANDICAP - 1000 metres (Cont'd)

**BUBBLERAP** (E. Finnegan) - began awkwardly, shifted out onto EQUAL LOVE, which was tightened onto RAY'S DREAM, which shifted in.

**EXALTED MAXINE** (R. Clark) - laid out throughout the event.

## RACE 7: HEINEKEN 3 HANDICAP - 1550 metres

**ENKI** (C. Jones) - rider reported the gelding hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

WHAT A SHOCK (NZ) (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

**PRINCE MONARCH** (G. Cartwright) - slow to begin losing three to four lengths. Trainer, Ms S. Nolan was advised a warning had been placed on the gelding in relation to it being slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**ZAGATO STAR** (D. Tourneur) - slow to begin losing two to three lengths. Near the 600 metres shifted out to improve and contacted WHAT A SHOCK, which was hampered. Mr D. Julius, Stable Foreman, for Trainer Mr R. Balfour was advised a warning had been placed on the mare in relation to it being slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**ASHADY HUSSY** (J. Toeroek) - shifted out near the 200 metres and hampered JUST LIVE ON. Rider reprimanded for shifting ground when insufficiently clear.

**JUST LIVE ON** (J. Eaton) - awkward to begin. Shortly after the start when tightened for room between PEWTER and MOGHUL EMPIRE, got its head up and raced ungenerously for a short distance. Near the 200 metres was hampered when tightened by ASHADY HUSSY, which shifted out.

# RACE 8: GUINNESS ST PATRICKS DAY - MARCH 16 AT MORPHETTVILLE HANDICAP - 1300 metres

**ACE ATTACK** (C. Jones) - underwent a pre-race veterinary examination and passed fit to race. Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**IN THE FAST LANE** (R. Hurdle) - underwent a pre-race veterinary examination and passed fit to race. Laid out in the straight. A post-race veterinary examination revealed no visible abnormalities.

**DE JORVIK** (M. Autier) - a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer Mr J. Hyam was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.
