RACE 1: QUAYCLEAN HANDICAP - 1050 metres

BAROOD (J. Huxtable) - awkward to begin.

DESPATCH (B. Vorster) - jumped away awkwardly. Difficult to load. Trainer advised a warning had been placed on the gelding in relation to its barrier manners.

DOMINATION (J. Holder) - laid out in the straight.

FANCY RUMBLE (K. Crowther) - inclined to lay in under pressure in the straight.

TIARA STAR (J. Kah) - laid in, in the straight. A post-race veterinary examination revealed no visible abnormalities.

SANDHILL FLASH (K. Bishop) - inclined to lay out in the straight.

DEL PIERO (D. Yendall) - knuckled on jumping away.

RACE 2: HIT107 HANDICAP - 2004 metres

DANE THUNDER (J. McNeil) - a post-race veterinary examination revealed a minor laceration to its off hind leg. First aid administered.

LIEDER (C. Caserta) - contacted at the start. In the vicinity of the 450 metres was tightened onto BRAMFIELD as TAHNEE TIARA rolled out.



RACE 2: HIT107 HANDICAP - 2004 metres (Cont'd)

BRAMFIELD (C. Parish) - raced keenly in the early stages of the event. Near the 450 metres was inconvenienced when taken wider by TAHNEE TIARA, which shifted out. Shifted out approaching the finish. Rider pleaded guilty to a charge of careless riding under AR131(a), the particulars being that whilst riding BRAMFIELD, approaching the finish he shifted out when insufficiently clear, taking the running of ETNA (FR) resulting in D. Dunn having to check his mount and losing his position. C. Parish was suspended from riding in races for a period to commence at midnight on Tuesday, 19 March and to conclude at midnight on Wednesday, 27 March 2019: a period of four (4) meetings.

TAHNEE TIARA (R. Clark) - rolled out near the 450 metres onto LIEDER, which was tightened onto BRAMFIELD. Rider reprimanded and advised to take greater care in future.

PASS THE GLASS (J. Maund) - raced keenly in the middle stages of the event. Laid in under pressure in the straight. Had difficulty obtaining clear ground from the entrance to the straight until in the vicinity of the 300 metres. A post-race veterinary examination revealed no visible abnormalities.

ETNA (FR) (D. Dunn) - began awkwardly, shifted out and contacted LIEDER. Held up for clear running from the entrance to the straight until in the vicinity of the 150 metres where it shifted out to obtain clear running. Approaching the finish was tightened for room and had to be checked and lost its position when awkward on the heels of BRAMFIELD, which shifted out under riding.

THE BEDOUIN (IRE) (T. Nugent) - awkward and slow to begin. A post-race veterinary examination revealed no visible abnormalities.

SHAKOPEE (GB) (J. Toeroek) - pulled hard in the early stages of the event.

LOSTARC (W. Pike) - raced wide without cover in the early and middle stages of the event.

RACE 3: LECONFIELD WINES HANDICAP - 1200 metres

YULONG KNIGHT (IRE) (J. McNeil) - approaching the 100 metres shifted in under riding tightnening HE WILL BOOM onto CARLALUISA. Rider pleaded guilty to a charge of careless riding under AR131(a), the particulars being that approaching the 100 metres he shifted in when insufficiently clear of HE WILL BOOM tightening that horse onto CARLALUISA resulting in HE WILL BOOM having to be restrained when hampered, losing its position, and CARLALUISA being hampered on the rail for several strides. J. McNeil was suspended from riding in races for a period to commence at midnight on Saturday, 16 March and to conclude at midnight on Wednesday, 27 March 2019: a period of five (5) meetings. Lost its near hind plate during the event. A post-race veterinary examination revealed no visible abnormalities.

EXALTED TRAIL (D. Dunn) - on jumping away bumped with GOTTE BE GOLD, which shifted out. Over-raced in the early stages of the event. Lost its of hind plate during the event.

STRYKE IN STYLE (J. Toeroek) - shorlty after the start bumped with CARLALUISA on a number of occasions. Inclined to lay in under pressure in the straight. Lost its near hind plate during the event.

GOTTA BE GOLD (J. Holder) - jumped away awkwardly, shifted out and bumped EXALTED TRAIL.

MESSERSCHMITT (J. Winks) - held up for clear running rounding the home turn.

CARLALUISA (R. Clark) - shortly after the start bumped with STRYKE IN STYLE on a number of occasions. Held up for clear running from the 400 metres until in the vicinity of the 300 metres. In the vicinity of the 100 metres became awkward for a number of strides when tightened by HE WILL BOOM, which was taken in. A post-race veterinary examination revealed no visible abnormalities.



RACE 3: LECONFIELD WINES HANDICAP - 1200 metres (Cont'd)

AVORA SUN (C. Caserta) - inside the 100 metres was tightened between STRYKE IN STYLE, which laid in, and LOPE DE WOLF, which was taken out by HE WILL BOOM and lost its position.

HE WILL BOOM (E. Finnegan) - approaching the 100 metres was tightened for room and was obliged to be steadied when taken in by YULONG KNIGHT (IRE), which shifted in. As a consequence the gelding lost its position and shifted out into the running line of LOPE DE WOLF hampering that horse.

LOPE DE WOLF (K. Crowther) - jumped away awkwardly. Held up for clear running from in the vicinity of the 200 metres until the finish. Inside the 100 metres was hampered when taken out onto AVORA SUN by HE WILL BOOM, which shifted out. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: MAGIC MILLIONS ADELAIDE 2YO CLASSIC - 1200 metres

THE EXECUTIONER (J. Holder) - raced keenly in the early stages of the event.

LIGHTHORSE LAD (C. Newitt) - raced keenly in the early stages of the event. Inside the 200 metres shifted out inconveniencing ANGEL ROCK, which was taken out onto HE'LL HAUNT US.

MOVIE ROLE (C. Brown) - a post-race veterinary examination revealed no visible abnormalities.

CHARVET (M. Walker) - near the 700 metres became awkward on the heels of SWING AND BOOM and shifted out.

MISS DYNAMIC (J. Winks) - laid in under pressure in the straight.

ANGEL ROCK (J. Kah) - awkward to begin. Inside the 200 metres was inconvenienced as LIGHTHORSE LAD shifted out.

DURABILITY (P. Moloney) - awkward to begin and lost ground.

RACE 5: HEINEKEN 3 HANDICAP - 1200 metres

EL SICARIO (NZ) (D. Dunn) - raced keenly during the event. In the vicinity of the 100 metres raced in restricted room for a short distance between RHYTHMATIC and BELLOMO, which rolled in. A post-race veterinary examination revealed no visible abnormalities.

BELLOMO (K. Crowther) - in the vicinity of the 100 metres rolled in onto EL SICARIO (NZ).

PRETTY GLASS (D. Yendall) - inside the 200 metres shifted out onto STAR STATUS, which was obliged to be eased when tightened onto OH MO. Rider was reprimanded for shifting ground when insufficiently clear. A post-race veterinary examination revealed no visible abnormalities.

SKY PUNCH (NZ) (T. Nugent) - slow to begin. A post-race veterinary examination revealed the gelding to have thumps and respiratory distress. Trainer Mr M. Hickmott was advised the results of a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race. First aid administered.

OH MO (S. Fawke) - hung in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

STAR STATUS (R. Clark) - inside the 200 metres was obliged to be eased when tightened onto OH MO as PRETTY GLASS shifted out.



RACE 6: SCHWEPPES C S HAYES MEMORIAL CUP - 1600 metres

MIGHTY BOSS (C. Newitt) - Trainer Mr M. Price was reprimanded under AR65 for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by Stewards. Inconvenienced on jumping away. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. Rider could offer no explanation for the horse's performance in today's event. A post-race veterinary examination revealed no visible abnormalities.

LITE'N IN MY VEINS (M. Walker) - a post-race veterinary examination revealed no visible abnormalities.

PRIZE CATCH (D. Yendall) - Trainer Mr J. McLean was reprimanded under AR65 for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by Stewards.

SILENTZ (J. Allen) - began awkwardly, shifted in onto MIGHTY BOSS, which was inconvenienced.

DODGING BULLETS (J. McNeil) - Trainer advised a change in tactics in that he would instruct J McNeil to be positive and to settle more forward than at its last start. Settled outside the leader. Raced keenly in the early and middle stages of the event.

MORVADA (J. Toeroek) - raced wide without cover throughout the event. Laid in, in the straight. Rider pleaded guilty to a charge under AR132(6) in that he used his whip in an action that raised his arm above shoulder height and was reprimended.

A SHIN ROOK (JPN) (J. Winks) - had difficulty obtaining clear running from the entrance to the straight until approaching the 100 metres. Rider was cautioned under AR132(6) for using his whip in an action that raised his arm above shoulder height.

MANTASTIC (IRE) (C. Brown) - slow into stride.

RACE 7: TAB ADELAIDE CUP - 3200 metres

EASTENDER - a late scratching by order of Stewards at 10.55 am under AR254. See General.

SYLPHEED (D. Tourneur) - jumped away awkwardly and shifted in. Raced keenly in the middle stages of the event.

AAGAS (C. Parish) - jumped away awkwardly and contacted FRANKED (GB).

DAWN RAID (D. Yendall) - a post-race veterinary examination revealed no visible abnormalities.

KHEZERABAD (FR) (J. McNeil) - began awkwardly and as a result lost ground.

EXALTED LIGHTNING (G. Cartwright) - over-raced and got its head up on a number of occasions in the early stages of the event.

AZURITE (IRE) (C. Caserta) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

SURPRISE BABY (NZ) (D. Holland) - laid in under pressure in the straight. rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$300. Rider also pleaded guilty to a charge under AR131(c) for making a celebratory gesture prior to the wining post and was fined \$500.

RACE 8: AAMI MATRICE STAKES - 1200 metres

The start of this event was delayed approximately two minutes.



RACE 8: AAMI MATRICE STAKES - 1200 metres (Cont'd)

WAGING WAR (R. Clark) - approaching the 800 metres had its hindquarters turned by STELLAR COLLISION, which fell. Laid out under pressure in the straight and brushed with SNITZKRAFT, which shifted out approaching the 100 metres and was taken wider on the track.

CASINO WIZARD (J. Holder) -raced keenly in the early stages of the event.

STELLAR COLLISION (D. Yendall) - approaching the 800 metres became awkward in its action and appeared uncoordinated behind and when restrained, shifted out into the running line of IMMACULATE SECRET, which was severely hampered for several strides and as a consequence KABINI, which was following was hampered for several strides and taken in onto STRAGUN, which was hampered for several strides. Thereafter STELLAR COLLISION continued to shift ground both ways and hampered ZALMONA, which was taken in. Shortly thereafter STELLAR COLLISION shifted out abruptly and contacted ONE MORE DAISY and fell as a consequence dislodging D. Yendall. As a result ONE MORE DAISY became very awkward and unbalanced, dislodging K. Crowther. As a further consequence, STELLAR COLLISION contacted the hindquarters of WAGING WAR, which was hampered. As a result CHAUFFEUR, which was following was severely hampered when its rider took evasive action to avoid the fallen horses. Shortly thereafter EMBLEY which was following was severely hampered and contacted the fallen STELLAR COLLISION and became unbalanced for several strides and as a consequence E. Finnegan was dislodged. As a consequence of the interference suffered by IMMACULATE SECRET this horse was eased out and took no further part in the event. A post-race veterinary examination revealed STELLAR COLLISION had suffered severe internal haemorage and was humanely euthanased. Rider examined by the First Care Medical Personnel and transported to hospital for further assessment and observation.

SNITZKRAFT (J. Allen) - jumped away awkwardly. Shifted out under pressure in the straight and in the vicinity of the 100 metres brushed with WAGING WAR taking that horse wider on the track.

CHAUFFEUR (C. Brown) - Co-Trainers were fined \$100 under AR65 for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by Stewards. Approaching the 800 metres was severely hampered and its rider was forced to take evasive action to avoid the fallen horse.

EMBLEY (E. Finnegan) - Trainer Mr W. Clarken was fined \$100 under AR65 for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by Stewards. In the vicinity of the 800 metres was severely hampered due to it being contacted by the fallen horse and became unbalanced for several strides and as a consequence, its rider was dislodged. Rider examined by the First Care Medical Personnel and cleared of injury. A post-race veterinary examination revealed no visible abnormalities.

ZALMONA (T. Pannell) - approaching the 800 metres was hampered and taken in as STELLAR COLLISION shifted in.

STRAGUN (D. Dunn) - approaching the 800 metres was hampered for several strides as KABINI was taken in by IMMACULATE SECRET, which was hampered by the fallen horse.

ONE MORE DAISY (K. Crowther) - approaching the 800 metres received heavy contact from the fallen horse and as a result became very awkward and unbalanced and dislodged its rider. Rider examined by the First Care Medical Personnel and reported fit to fulfil her remaining engagement. A post-race veterinary examination revealed lacerations to the off fore cannon. First aid administered.

KABINI (D. Tourneur) - approaching the 800 metres was hampered for several strides and was taken in onto STRAGUN by IMMACULATE SECRET, which was hampered by the fallen horse and shifted in. A post-race veterinary examination revealed the mare to be lame in the near foreleg and near hind leg. Trainer Mr B. Brook was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race. First aid administered.



RACE 8: AAMI MATRICE STAKES - 1200 metres (Cont'd)

IMMACULATE SECRET (S. Baster) - approaching the 800 metres was severely hampered when STELLAR COLLISION shifted out into its running line prior to it falling. Obliged to be restrained to avoid the fallen horse and took no further part in the event.

Correct weight was delayed to allow R. Clark, the rider of, and Co-Trainer Mr Macdonald (WAGING WAR) placed second to view the vision in the straight. After doing so, Mr Macdonald lodged an objection against SNITZKRAFT being declared the winner, alleging interference in the straight. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards took into account the racing manners of both runners and the fact that WAGING WAR laid out of its own accord as well as SNITZKRAFT shifting out under pressure and both runners brushing slightly at the 100 metres. Stewards noted that while WAGING WAR was taken wider for a short distance the incident did not in their opinion materially affect the outcome of the result and consequently *dismissed* the objection.

RACE 9: TAB HANDICAP - 1600 metres

The start of this event was delayed approximately five minutes owing to the fall and protest in the previous race.

MISTA HOLYFIELD (G. Cartwright) - raced keenly in the early stages of the event.

CANNOT BE SERIOS (NZ) (T. Nugent) - shifted out in the vicinity of the 100 metres and inconvenienced DANGER DEAL. Rider was severely reprimanded for shifting ground when insufficiently clear.

DANGER DEAL (R. Clark) - inconvenienced near the 100 metres by CANNOT BE SERIOS (NZ), which shifted out.

YANKEE EYES (K.Crowther) - a post-race veterinary examination revealed no visible abnormalities.

DOWNUNDER PRINCE (D. Tourneur) - laid out from near the 600 metres. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$100. D. Tourneur was also fined \$100 for leaving the course after his last engagement without Stewards permission.

GENERAL:

RACE 7: TAB ADELAIDE CUP - 3200 metres (Additional Report)

During a routine stable inspection on race morning, Thoroughbred Racing SA Stewards became concerned with regard to race-day treatment practices involving the horse EASTENDER. Following an initial inquiry with the Trainer Mr Barry Campbell, Stewards declared the horse a late scratching at 10.55 am acting under the provisions of AR254. Stewards also interviewed Stable Foreman Ms T. Coward in respect of the matter. Both Mr Campbell and Ms Coward were advised that the inquiry had been adjourned to a date and time to be fixed.
