

THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 16 March 2019

TRACK: Good 4 (Track with some give in it)

RAIL: Out 4 metres entire. Sectional 605 metres.

WEATHER: Fine

RACE 1: SCHWEPPES HANDICAP - 1000 metres

HEAVEN'S DEAL (C. Jones) - laid out in the straight.

DANCER'S KIN (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

VIDUKA (C. Parish) -raced keenly in the early and middle stages of the event.

RACE 2: JAMES BOAGS TWO-YEAR-OLD MAIDEN PLATE - 1000 metres

CHILLI PRAWN (S. Cahill) - laid out throughout the event. A post-race veterinary examination revealed the colt to be lame in the off hind leg. Co-trainers, Mr T & Ms K O'Sullivan, were advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

NEW TESTAMENT (R. Hurdle) - began awkwardly, shifted in and contacted INCITER.

INCITER (B. Vorster) - began awkwardly, shifted out and contacted NEW TESTAMENT.

VALI ROSE (D. Tourneur) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 3: ELTON JOHN EXPERIENCE - JULY 27 AT MORPHETTVILLE MAIDEN PLATE - 1250 metres

The start of this event was delayed approximately five minutes owing to HILDISVINI having to be re-shod.

HILDISVINI (R. Hurdle) - required to have its off fore plate replaced on arrival at the barriers. Underwent a pre-race veterinary examination and was passed fit to start.

SCOUT'S HONOUR (R. Clark) - rider accidentally dropped her whip in the vicinity of the 200 metres.



RACE 3: ELTON JOHN EXPERIENCE - JULY 27 AT MORPHETTVILLE MAIDEN PLATE - 1250 metres (cont'd)

LANGKAWI (S. Cahill) - laid in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

MONRAAJ (M. Autier) - began very awkwardly and was very slow to begin. Thereafter laid out severely rounding the turn near the 900 metres and raced very wide without cover from that point on. Trainer, Mr R. Balfour, was advised that the gelding was now required to jump on terms with the field and race tractably in an Official Barrier Trial prior to a future race. A post-race veterinary examination revealed a small laceration to the near hind leg.

WAN CHI WARRIOR (C. Jones) - raced greenly in the straight.

ISLAND GAME (E. Finnegan) - tightened at the start between LANGKAWI and CAZABILLIE, which both shifted ground. Rider reminded of her obligations to ride her mounts out to the finish. A post-race veterinary examination revealed the filly to be lame in the near foreleg. Trainer, Ms J. Taylor, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

RACE 4: MYPUNTER.COM HANDICAP - 1400 metres

UNFAIR DISMISSAL (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

PERFECT AWARD (T. Pannell) - raced keenly in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RESURGE (B. Vorster) - a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr T. McEvoy, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

HAVANA HEAT (J. Toeroek) - raced keenly in the early stages of the event.

RAGING QUEEN (E. Finnegan) - had difficulty obtaining clear running shortly after the entrance to the straight and was obliged to shift out to obtain clear running approaching the 200 metres. Rider reported that the slow tempo in this event may not have suited the filly in running.

MAGNETIC ROSE (J. Eaton) - awkward to begin.

RACE 5: AAMI HANDICAP - 1400 metres

PASEETO (J. Huxtable) - rider reported that the gelding was one paced and raced flat in today's event.

SILENT ICE (C. Jones) - from near the 400 metres had difficulty obtaining clear running and was obliged to shift out near the 300 metres to obtain clear running.

DANOULI (S. Fawke) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

THRONES (D. Tourneur) – a post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr S. Adams, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

EURO GOLD (A. Jordsjo) - Stewards granted permission for A. Jordsjo to ride this gelding half a kilogram over weight (A. Jordsjo only claimed 1.5 kg of her 2 kg allowance). A. Jordsjo was fined \$200 under AR143(14)(a) for failing to claim her full allowance. A post-race veterinary examination revealed no visible abnormalities.



RACE 6: HUGHES LIMOUSINES HANDICAP - 1300 metres

NODOUBTABOUTIT (E. Finnegan) - stood flat-footed and was slow into stride. Shortly after the entrance to the straight raced in restricted room for a short distance between LA LA LUCHIE, which maintained its line, and COMMANDING DIVA, which shifted out to improve. A post-race veterinary examination revealed no visible abnormalities.

COMMANDING DIVA (C. Lions) - shortly after the entrance to the straight shifted out to improve inconveniencing NODOUBTABOUTIT. Rider reminded of her obligations when shifting ground.

RACE 7: TAB HANDICAP - 1950 metres

DANCE OF HEROES (GB) (R. Clark) - a post-race veterinary examination revealed no visible abnormalities.

IGITUR (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

TIPS AND BEERS (S. Fawke) - jumped away awkwardly and was slow to begin.

RACE 8: NUTELLA PALOOZA - APRIL 20 AT MORPHETTVILLE RACECOURSE HANDICAP - 1250 metres

TWO ODD SOX (S. Cahill) – approaching the 100 metres improved into a tight run between BY THE POUND and WITH A BIT OF DASH, and shortly thereafter shifted out and away from BY THE POUND and brushed with WITH A BIT OF DASH. As a consequence, WITH A BIT OF DASH shifted out abruptly into the running line of AMBERTONE, which was obliged to be steadied and hampered when taken wider.

AUTUMN STREET (C. Jones) - awkward to begin.

WITH A BIT OF DASH (T. Pannell) - in the vicinity of the 100 metres was brushed by TWO ODD SOX, which shifted out and away from BY THE POUND. As a consequence WITH A BIT OF DASH shifted out abruptly into the running line of AMBERTONE, which was obliged to be steadied and hampered when taken wider.

RED DAZZLE (C. Lions) - a post-race veterinary examination revealed no visible abnormalities.

LA MAGIQUE (C. Parish) - awkward to begin. Raced keenly in the early stages of the event.

AMBERTONE (R. Clark) - in the vicinity of the 100 metres was obliged to be steadied and was hampered when taken wider by WITH A BIT OF DASH, which shifted out abruptly
