Report on Race Meeting held at Penola Racecourse
by the Millicent Racing Club on Sunday, 31 March 2019

RACE 1: THE SOUTH EASTERN TIMES / SABOIS MAIDEN PLATE - 1300 metres

DARILJON (J. Lorensini) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$400.

THAT'S TWO SLABS (J. Maund) - laid in under pressure in the straight.

PLAYFUL HOST (R. Clark) - jumped away awkwardly.

CRIMSON QUEEN (C. Puls) - Trainer Mr A. Cosgriff informed Stewards prior to the event that he would instruct his rider to attempt to lead in today's event. Settled at rear. Slow to begin. Rider reported the filly felt sore in its near hind leg during the event. A post-race veterinary examination revealed mild contrusions to the near hind hock.

RACE 2: GALPINS ACCOUNTING & AUDITORS / SABOIS MAIDEN PLATE - 1100 metres

The start of this event was delayed approximately seven minutes.

BEAR PASS (C. Jones) - jumped away awkwardly. Inside the 800 metres was inconvenienced when racing tight to the inside of MONT AGEL.

MONT AGEL (K. Bishop) - On Thursday, 28 March 2019, Trainer Mr P. Ryan (Jnr) made application to the Stewards for the gelding to race in a tongue-tie. Stewards acceded to the request and granted permission for MONT AGEL to run in a tongue-tie. Trainer was reprimanded under AR206(2). In assessing penalty, Stewards took into account the timing of the application and his clean record in this area.

RACE 2: GALPINS ACCOUNTING & AUDITORS / SABOIS MAIDEN PLATE - 1100 metres
(Cont'd)

BLAME RODNEY (J. Maund) - raced keenly in the early and middle stages of the event.

SAHARA RIVER (E. Boyd) - fractious behind the barriers. Reared and dislodged its rider. Made heavy contact with an outside fence before proceeding through it and then galloping riderless for some distance. Acting on veterinary advice, Stewards withdrew SAHARA RIVER at 1.25 pm. Trainer Mr J. Searle was advised a warning had been placed on the filly in relation to its pre-race behaviour. Rider was examined by the First Care Medical Personnel and passed fit to fulfil her remaining engagements. A post-race veterinary examination revealed a small scratch to the near hind leg.

RACE 3: SPORTSMAN'S HOTEL / SABOIS MAIDEN PLATE - 1700 metres

The start of this event was delayed approximately three minutes.

BODIDLEY (J. Maund) - in the vicinity of the 1400 metres was hampered as GOOD TIME MADAM, which was restrained, shifted in. Approaching the finish shifted in and tightened GOOD TIME MADAM onto MISS WAZZA, which was taken out. Rider reprimanded under AR131(a) for careless riding and advised to take greater care in future.

MISS WAZZA (J. Potter) - dislodged its rider en route to the start. Underwent a pre-race veterinary examination and passed fit to race. Rider examined by the First Care Medical Personnel and ruled fit to fulfil his remaining engagements. Shortly after jumping away rolled out and bumped AUSTRALIEN. Approaching the finish was taken out onto GOOD TIME MADAM by RAINCUTTER. A post-race veterinary examination revealed no visible abnormalities.

RAINCUTTER (D. Bates) - in the vicinity of the 1400 metres was hampered as BODIDLEY was taken in. Held up from the entrance to the straight until inside the 200 metres where it shifted in to obtain clear ground. Approaching the finish rolled out onto MISS WAZZA, which was taken out.

AUSTRALIEN (S. Fawke) - shortly after jumping away bumped with MISS WAZZA, which shifted out.

GOOD TIME MADAM (E. Boyd) - approaching the 1400 metres, when racing keenly, shifted in when being restrained onto BODIDLEY, which was hampered and taken in onto RAINCUTTER, which was inconvenienced. Rider severely reprimanded under AR131(a) for careless riding and advised to take greater care in future. Rider was further reminded of her obligations in relation to reducing the pace of the race. Approaching the finish was tightened onto MISS WAZZA, which was taken out by RAINCUTTER as BODIDLEY shifted in.

REDEMPTION STREET (M. Autier) - over-raced in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: COOPERS DRY BENCHMARK 60 HANDICAP - 1100 metres

SNIPPY STRATEGIC (D. Bates) - had difficulty obtaining clear ground from the entrance to the straight until approaching the 100 metres.

TEATRO (A Jordsjo) - slow to begin.

CASINO MAGIC (J. Maund) - raced wide without cover throughout the event.

RACE 5: JOHN CHAY & CO LIVESTOCK BENCHMARK 80 HANDICAP - 1100 metres

RHYTHMATIC (D. Tourneur) - jumped away awkwardly and was slow to begin. Lost its near hind plate during the event.

FRANCE'S BOY (S. Fawke) - jumped away awkwardly. Rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200.

RUBYTOO (K. Bishop) - underwent a pre-race veterinary examination as it had not raced since January 2018 and passed fit to race.

RACE 6: DI GIORGIO FAMILY WINES BENCHMARK 60 HANDICAP - 1400 metres

IAMTHEKEY (J. Huxtable) - jumped away awkwardly. Difficulty obtaining clear ground rounding the home turn for a short distance. Inside the 200 metres was inconvenienced when tightened onto COTILLION as LITTLE HEATH rolled out.

EMIL (S. Logan) - slow into stride.

DYADAMO (J. Maund) - acting on conformed advice from Trainer Mr R. Nicholson that the gelding was suffering from a rash from a possible spider bite, Stewards withdrew DYADAMO at 11.38 am. Trainer was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

DESERT SPIRIT (C. Jones) - in the vicinity of the 1200 metres shifted in onto LITTLE HEATH when insufficiently clear, as a result LITTLE HEATH was obliged to be checked when tightened onto BEL MOSHE, which was hampered. Rider pleaded guilty to a charge of careless riding under AR131(a) in that she shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday 6 April and to conclude at midnight on Friday 12 April 2019: a period of three meetings.

LITTLE HEATH (J. Lorensini) - in the vicinity of the 1200 metres was obliged to be checked when tightened onto BEL MOSHE, which was hampered as DESERT SPIRIT shifted in when insufficiently clear. Inside the 200 metres shifted out onto IAMTHEKEY, which was tightened onto COTILLION.

TROOPER'S PLOY (S. Fawke) - jumped away awkwardly, as a result was unbalanced for a stride and consequently was slow to begin.

COTILLION (T. Farrugia) - inside the 200 metres was tightened onto TAN CHECK (NZ), as IAMTHEKEY was taken out.

BEL MOSHE (K. Bishop) - rider reported the mare hung out during the event.

RACE 7: 3MP STEEL ROOFING & FENCING SUPPLIES MILLICENT CUP - 1700 metres

ZEBRINZ (D. Bates) - slow into stride. At the entrance to the straight shifted out onto KEDNELLY, which was weakening and was obliged to be eased when tightened onto COUGAR EXPRESS. Rider was severely reprimanded under AR131(a) for careless riding.

TAHNEE TIARA (R. Clark) - a post-race veterinary examination revealed no visible abnormalities.

PASS THE GLASS (J. Maund) - jumped away awkwardly, shifted out and bumped HASTA LA THOMAS.

KEDNELLY (E. Boyd) - at the entrance to the straight was obliged to be eased when tightened onto COUGAR EXPRESS as ZEBRINZ shifted out. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: 3MP STEEL ROOFING & FENCING SUPPLIES MILLICENT CUP - 1700 metres (Cont'd)

HASTA LA THOMAS (C. Puls) - bumped on jumping away with **PASS THE GLASS**. Over-raced throughout the event.

RACE 8: SOMERSET HOTEL/MOTEL/SIP & SAVE BENCHMARK 56 HANDICAP - 1700 metres

DANOULI (T. Farrugia) - approaching the 400 metres dipped for no apparent reason.

DODGE CITY (K. Usai) - slow into stride. Stable Representative Ms T Onyett was advised a warning had been placed on the gelding in relation to its manners in which it began.

LONGMIRE (D. Tourneur) - raced fiercely in the middle stages of the event. Trainer Ms S. Murphy was advised a warning had been placed on the gelding in relation to its racing manners. A post-race veterinary examination revealed no visible abnormalities.

LADY DEE DEE (C. Jones) - slow to begin. Trainer Mr D. Dodson was advised a warning had been placed on the mare in relation to the manner in which it began.
